## 1. BOARD-SUPERINTENDENT GOVERNANCE

Minutes:

The following items were discussed:

- Board Member Hazouri requested information on Guidance Counselors and the budget. The Superintendent indicated this would be discussed during the budge topic later today.
- Board Member Hazouri asked if the information on KIPP was ready.
- Board Member Gentry requested information on E-Rate and the 10 to 1 matching funds. The Superintendent will ask Dr. Terri Stahlman, Chief Technology Officer, to provide an update to the Board.
- Board Member Wright expressed concern over the recent Times-Union article regarding the Superintendent Search. We need to make sure the process is as transparent as possible during this critical time for our district.
- Board Member Couch shared information regarding a recent visit with Chris Force, Director of Career and Technical Education, regarding the Cecil Commerce Center. The issue of middle school career academy certifications was discussed. The district is including this in our legislative package for the coming year.
- The Chairman indicated the need to make sure staff was aware they are concerned with morale and paperwork.
- Chairman Burney shared information on a visit to Loretto Elementary School and how well Principal Chris Begley has obtained technology and training for his staff. She suggested that other schools look at what Loretto is doing and replicate at their schools.
- Board Member Gentry talked about Read It Forward and its impact on writing scores.

## The Superintendent shared the following:

- KIPP he will ask staff to provide the best prediction on KIPP. He reminded the Board that Charter Schools are not required to use FAIR, however, they are not entitled to reading dollars if they do not use FAIR.
- E-Rate he will provide the Board with an update.
- The Superintendent will provide a report to the Board on career academy certification issues.
- The Superintendent will also update the Board on DA and how it impacts OSC.
- The Superintendent shared that the SOS Charter School hearing is scheduled for May 23, 2012.
