1. PLACEMENT: FINAL ORDER RE: DUVAL COUNTY SCHOOL BOARD VS. RHONA SILVER

Minutes:

The Chairman welcomed everyone present, and explained the item before the Board today in the case of Duval County School Board cs. Rhona Silver. The issue before the Board today is for reimbursement of attorney fees for Ms. Silver. Each side will have 8 minutes.

Mr. Bill Shepard, attorney at law, presented on behalf of Ms. Silver. He believes that it is wrong for her to have to use all of the back pay she is receiving to pay for attorney fees. He spoke to the charges and that she had been exonerated from all of the charges. Mr. Shepard indicated that he had tried to mediate with the school system attorneys for granting this request, but had not been successful. He indicated that he will take the case to the First District Court of Appeals if we do not agree. Mr. Shepard believes that since his client was found innocent, that she should be entitled to attorney fees, and quoted Florida Statutes that says if an employee successfully defends themselves in a legal action, they are entitled to attorney fees.

Mr. Mike Weidner, Assistant General Counsel, Office of General Counsel, presented on behalf of the school system. Mr. Weidner pointed out that the Florida Statute referred to by Mr. Shepard does not apply to this proceeding, and only refers to officers of the school system, and Ms. Silver is not an officer of the school system. *Workman vs. Seminole County* is binding and there have been no findings to the contrary. The Administrative Law Judge specifically addresses this matter on pages 97-98 of his Final Order.

After some discussion, the Chairman read an excerpt where the Administrative Law Judge stated in his final order that these legal fees were incurred in an administrative proceeding and not a criminal or civil proceeding, and, therefore, it would

be inappropriate to award attorney fees. In order to find contrary to that opinion, the Board would have to find that he is incorrect in his findings of law.
