PRE-TRIAL DETENTION FACILITY

Minutes:

Board Members were escorted by Officer Deon Johnson and Principal Edward Robinson on a tour of the Pre-Trial Detention Facility. During the tour they were able to visit classrooms, speak with students and teachers.

• Currently the facility has 71 students.

- The students are offered transition services.
- Florida Ready to Work is one of the transition programs that offers an opportunity for students to go into the work force.

DUVAL REGIONAL DETENTION CENTER

Minutes:

Board Members were escorted by Captain Harris and Donaldo Harris, Vice-Principal, on a tour of the Duval Regional Detention Center. During the tour they were able to see classrooms, students and teachers.

Board Members inquired about transition programs to prevent a repeat of the same students. A transition specialist is assigned to work with the students.

- Currently there are over 90 students at the facility with a capacity of 100.
- The students are grouped into 5 groups: Alpha, Bravo, Charlie, Delta and Hotel. Delta is used for overflow and Hotel is for female students
- The Facility also serves Nassau and Clay county students.
- Staff would like to see students assigned to a mentor.

GRAND PARK EDUCATION CENTER

Minutes:

Board Members were escorted by Dr. Tyrone Blue, Principal, on a tour of Grand Park Education Center. During the tour they were able to visit classrooms, speak with students and teachers.

- Currently the Education Center has 201 students.
- Students and their families receive orientation before starting at the Education Center.
- Dr. Blue would like to see vocational programs offered.
- There is a Transition Specialist to help students transition back into the traditional school.
- Students work through "How Did I End Up Here" by Rick Lewis with the Transition Specialist.
