Their autistic student was finally settling in well with his case manager when he was suddenly told the manager would no longer be working at the school. Autistic students need time to transition and the program doesn't seem to understand that.

The District Advisory Council meeting was Monday, March 27, 2017, at 6:00 p.m. Dr. Dana Krisnar once again represented the Superintendent and his cabinet well. You are truly amazing! The District Advisory Council thanks you for providing an overview of what's going on in the school district, answering some difficult questions, researching, and bringing attention to our concerns so the next month we will not address the same concerns. In the past month the DCCPTA has traveled to Tallahassee twice in March. COMMENTS FROM DISTRICT STUDENT GOVERNMENT ASSOCIATION

Gerrold Williams, Vice-President, Jacksonville Association of Governing Students (JAGS)

Since our last report, we have held three meetings, one on February 8, February 22, and March 8. During these meetings, our main focus was creating a project that would leave a resonating impact in our schools, county, and community.

During the month of February, we focused our energy defining student engagement opportunities in schools. We began by defining what we believe the role and responsibility of student government should be in the school environment. We then collected evidence to see how schools have been harnessing those student opportunities in schools. We believe student engagement opportunities should be more defined and consistent across schools.

After a brief discussion at our March meeting, a general consensus was reached and we decided that we would begin to work on organizing an event, the Student Voice Summit. This event will be the first of its kind. The event has been designed and planned by the JAGS representatives for each high school community in Duval County Public Schools. School administration, teacher leaders, advisors, sponsors, and student representatives have been invited to participate in the conversation to improve student experiences and engage, elevate, and empower student voice within each high school. We are motivated to engage our peers through various opportunities and connect our school communities to the district student organization and the state student organization. We believe that strengthening these connections will create a cohesive representation across all student organizational opportunities. By elevating the voice of Duval's students, we believe they will become more engaged in the educational environment and culture and outcomes will improve over time. The event will take place in the evening to ensure instructional time will not be interrupted during this critical time of the school year.

The overall goal of this event is to increase student engagement and improve student experiences within schools. To do this we are looking to revolutionize each schools' individual Student Government and/or Council, since this is one of the primary channels of student voice. Along with

this, we have devised school-based strategies for increasing student engagement that we will share with the schools.

Overall, we believe that if we implement these initiatives and practices into each school, then collectively as a county, we will see a significant increase in student morale, leadership, and engagement. JAGS intends to follow up with each school after the summit is held to assess and discuss the successes and barriers that each individual school may encounter.

Our next meeting will be held tomorrow, April 5 from 3:30-5:30 pm here at the School Board Building in Room 307. All of our meetings are open and all students are more than welcome to attend. Thank you all for your time and a special thank you to the Board, Chairman, and Superintendent for providing JAGS with this unprecedented opportunity for student leadership, engagement, and advocacy.

Minutes:

In light of the fact that there is still no budget in place and this item would be a revolving cost every year, Board Member Hershey is concerned about finding funds for this item. She understands that this ID system would improve student safety and considers that important, but moved that the item be amended to defer to a time certain of June 6, 2017.
