RECOGNITION - AMERICAN HEART ASSOCIATION

Minutes:

The American Heart Association wishes to formally recognize the Duval County School Board Chairman and Vice-Chairman. Approximately 420,000 Americans suffer cardiac arrest each year, with only 9.5 percent surviving. With every minute that blood isn't circulating, and the body is deprived of oxygen, the chances of survival decrease by 10 percent. After 10 minutes without CPR, the chance of survival is virtually nonexistent. It is clear that early CPR is a critical link in the chain of survival.

At the February School Board Meeting, the American Heart Association presented Duval County's CPR training program with 22 additional CPR kits. Every middle and high school will have its own kit, with six kits rotating among elementary schools. Over 11,000 students have been trained in CPR over the past three years, but the training doesn't stop with students.

Tonight, the American Heart Association is presenting certificates of completion to Chairman Ashley Smith Juarez and

Vice-Chairman Paula D. Wright because they too have been trained in Hands-Only CPR. Joining us tonight from the American Heart Association is Vice-President and First Coast Executive Director Kristin Kyle along with Youth Market Director Mark Owens.

RECOGNITION - COMMUNITY PARTNER DREAMS COME TRUE

Minutes:

Since 1984, Dreams Come True has made into reality the dreams of more than 3,000 children battling life-threatening illnesses. This partnership with DCPS began when high school students from Robert E. Lee, Mandarin, Paxon School for Advanced Studies, and Westside High Schools collaborated to host the Boys Basketball Tipoff Classic. This was also supported by Chartwells and the I'm A Star Foundation. The goal was to use the proceeds from the tournament to sponsor a dream for a Lee High School student, who unfortunately passed away before the dream could be fulfilled.

The partnership continued in June, when the district and several Lee and First Coast High School programs joined Dreams Come True for the Dream Day Parade. That's when "Dreamers" had an opportunity to spend a day in a magical wonderland of all their favorite characters, and enjoyed food and fun through the organization's partnership with PRI Productions.

### Chairperson's Report

### CHAIRPERSON'S REPORT

#### Minutes:

Ashley Smith Juarez, Chairman, Duval County School Board

I want to remind everyone that school starts early this year: August 15. The Board approved this calendar following the 2015 legislative session. The legislature removed a rule that would restrict any district that was not high performing according to the State Accountability System from starting more than two weeks before Labor Day. If you follow that line of thinking, high performing districts had the opportunity to start earlier, so their students were in school longer before they sat for the State test which deems districts high performing. We, as a Board, felt like it was advantageous to our students and school communities to be able to take advantage of the rule removal and start earlier so our students and teachers have more time with the material and to prepare for the State tests. We know this year's summer was a little shorter than is typical but understand, the school year will also end earlier. I encourage everyone to get back into their school routine.

Tax free holiday is this weekend, August 5-7. Many schools distributed summer learning packets and reading suggestions for students. Now would be a good time to review those.

The Board has approved the tentative budget for the 2016-2017 school year. The Special Meeting for the final vote will be September 8. If you have questions or comments, please contact your Board Member.

Dr. Nathaniel Glover, President, Edward Waters College

Dr. Glover thanked the Board Members for their willingness to lease the James Weldon Johnson property to Edward Waters College. He noted that, in the past, the college used to be the number one provider of African-American teachers to the school district and his goal is to get back to that position again. He also looks forward to working with DCPS to put more African-American males in the elementary schools.

### Timothy Sloan

Mr. Sloan sent a news article to all the Board Members that was written about the three failing schools. He supports Dr. Vitti's plan to convert Northwestern Middle School to the Young Men's and Young Women's Leadership Academies.

### John Turner

Mr. Turner asked the Board to consider voting down the Literacy Plan on the agenda citing that it would do children more harm than good. He opined that much of it is due to a lack of high quality phonics. He feels the Saxon program being used by the District is a weak program. Mr. Turner has asked for information concerning the phonics information but doesn't get the information he requests.

# Lucille Rafidi, Advocate

Ms. Rafidi sent an email to all the Board Members listing what she sees as the top five concerns that should be addresses and resolved. She reviewed four of the five concerns which were:

- A need for cameras in the classrooms
- Media centers and the materials in them
- Personal data and searches
- The importance of working phones/call buttons/walkie talkies

### Eric Fields, Teacher

Mr. Fields asked the Board to consider eliminating 11th and 12th grade Honors classes. He has been teaching for 23 years. During that time he has observed that there is not much difference between the curriculum of the two. Deciding to eliminate the Honors classes would not incur any cost to the District but would increase the number of students choosing more rigorous coursework. Vice-Chairman Wright recognized the Honorable Evelyn Coney, Saltwater Commissioner.
