Operational Audit Finding 4 dealing with Professional Architectural Services was discussed. This finding involved a re-use agreement for plans from St. Johns County which were approved by the Board, but not used. Staff actually used an existing contract for the services. Staff agreed that these were not handled in the appropriate manner and that steps are being taken to correct and make sure this does not happen again.
