## RECOGNITION - ATLANTIC COAST HIGH SCHOOL ENVIROTHON WINNERS

## Minutes:

The Duval Soil and Water Conservation District consists of five elected Supervisors and 3 Affiliate Members that work with federal, state and local agencies to conserve soil and water resources in Duval County. Our mission is to promote the wise use of land and best management practices and education that will conserve, improve and sustain the natural resources of Duval County. The Board has continuously supported the Envirothon through funding and promotion because of its direct connection between students and land conservation.

The Envirothon is a national high school competition with program focuses on Aquatic Ecology, Forestry, Soils/Land Use, Wildlife, and a Current Environmental Issue. Duval County high

schools are encouraged to participate and enter up to two teams. Winners of the Duval County competition will move on to the Florida statewide competition. Winners of the Florida State competition move on to compete in the North American Envirothon. These interrelated and broad study areas teach a holistic approach to natural resource conservation and can easily be incorporated into a teaching curriculum.

In 2015, Dave English, the team sponsor for Atlantic Coast High School, helped prepare and teach the winning team from Duval County, out of more than 20 competing teams. Because of his hard work, soil and water resources were added to an already tight curriculum, and many students were afforded the opportunity to compete and ultimately represent Duval at the Florida State competition where they placed third overall in Aquatic Ecology. The 2016 Regional Envirothon will be held on March 10, 2016 at Tree Hill Nature Center.

# Chairperson's Report

## CHAIRPERSON'S REPORT

#### Minutes:

Ashley Smith Juarez, Chairman, Duval County School Board

All Board Members went to the floor to present a Past Chairman Award to Board Member Cheryl Grymes to thank her for her service as Chairman during the past year.

Some of our Board Members were involved in professional development at the Florida School Boards Association's Annual Joint Conference last week. Board Member Couch earned her Master Board certificate a couple of years ago. Several others are working toward theirs. There were many examples of great ideas being executed in districts across the state and important conversations about policy at the local, state and national levels.

As a reminder to our stakeholders, the legislative session is early this year. Legislators are meeting in committees now and the session will open in January. I want to thank Ms. Couch for speaking to the Duval Delegation on behalf of the Board today. I would encourage parents, teachers, and all community members to review our legislative agenda that is on the website. I do want to call your attention to a couple of items.

• First, we have been able to find a solution working with the Department of Education for literacy instruction for students in those elementary schools identified as part of the Lowest 300. Because our regular elementary school calendar already exceeds the minimum number of

hours, schools will not continue the extra hour after the winter break.

We will still deploy resources for students in these schools to receive additional supports as well as students who are not performing at grade level across the district. This solution allows us to be more strategic with our resources and to use interventions that have proven more effective.

We appreciate the Department of Education working with us to devise a solution that is best for students.

• Second, this Board repeatedly has affirmed accountability as an important part of educating every student, every day. However, we have also asked that with the transition to the new standards and FSA that the 2014-2015 scores that will be released in late winter be used to create a baseline year, that school grades not be issued and that students and teachers be held harmless. As a reminder to stakeholders, the State Board will be considering cut scores which will define proficiency on the FSA. The public is encouraged to read up on proposals of what those scores should be and contact lawmakers to express viewpoints.

Lauren Flannegan, AmeriCorps Member, City Year

Ms. Flannegan's parents instilled in her that education is important and everyone is capable of greatness. She enjoys being able to pass that onto the students she works with at Highlands Middle School through City Year. She gave an account of working with one of her students that supported that idea.

Josh Rosenbladt, Impact Manager, City Year

Mr. Rosenbladt came to Duval County a year ago from Oklahoma where he taught high school math. He joined City Year because of his belief in the direction of Duval County Public Schools and his belief in the community. Principal Simmons at Highlands Middle School charged the volunteers from City Year with the task of improving the school's image within the community. The school is working hand in hand with the community to clean up the campus as part of the Martin Luther King, Jr. Day of Service.

Haiden Christian, 2nd grader, Duval Charter School at Westside

Haiden gave an extensive list of what it is he likes about his school.

Joanne Steele, Parent, Duval Charter School at Westside

Ms. Steele gave an account of her daughter's educational journey since it began, switching back and forth between charter and public school. She favors the charter school's style of teaching and has started thriving in the charter school atmosphere.

Debbie Barnes, Media Worker, Beauclerc Elementary School

Ms. Barnes expressed her concern about the method used to incorporate the First Grade curriculum at her school. While the curriculum exposes children to ideas that are irrelevant to their way of life here in our country, it robs them of their opportunity to learn in-depth lessons about their own culture such as our first Thanksgiving. She expresses concern about how religion is being addressed in the curriculum to students at such a young age and is concerned about some of the questionable ties EngageNY has. She is concerned that we, as a nation, will fall apart if we fail to teach our children about the history of their own country while they are young.

Steve Charlton, graduate and teacher of Terry Parker High School

Mr. Charlton spoke of the high turnout at the community meeting at Terry Parker High School and the opposition of the boundary changes proposed. Although there are many issues, he addressed one specific issue of building utilization there at the school. He doesn't feel the school is underutilized. The growing programs are bringing back more neighborhood students but boundary proposals would bring in even more students from other schools, such as Wolfson High School. He feels the change would solve Wolfson High School's problems, but on the back of Terry Parker High School.

Christine Sapienza, Dean of Brooks Rehabilitation College of Health Care Sciences and Program Director of Speech Language Pathology Program, Jacksonville University

Ms. Sapienza gave some background information to the joint relationship that has been formed between Jacksonville University and Duval County Public Schools and the plans they have for the GRASP program.

**COMMENTS FROM PARENT ORGANIZATIONS** 

Minutes:

Karen Nuland, President, Duval County Council of PTA (DCCPTA)

We have been very busy this fall providing Leadership Training for PTA members, such as Presidents and Treasurers' Training and Time Management and Conflict Resolution. We have been working with high school students on being advocates for their schools and their

communities through our National Award winning Superintendent's Leadership Academy. We also had the Duval Legislative Delegation speak at our October General Membership Meeting.

Our leadership has also worked with over 130 schools to ensure their PTAs are functioning at the highest level. We are also participating in the community discussions about school redistricting boundaries and school repurposing. Interviews are being conducted with teachers for the EDDY Awards' Teacher of the Year selection with the Jacksonville Public Education Fund.

We continue to work with community organizations to bring information and services to the parents of our students, such as Tobacco Free Duval, Teachers' Supply Depot and Healthy Jacksonville. We have also worked with schools in starting or restarting their PTAs.

All of these activities engage parents, students, teachers, grandparents, principals and the community in our Public Schools.

Sabrina Zinamon, President, District Advisory Council (DAC)

The District Advisory Council meeting was held Monday, November 23, 2015 at 6:15 p.m. Thank you to Chairman Smith Juarez and Superintendent Vitti for their presence at the meeting.

Chairman Smith Juarez gave a breakdown of how the proposed boundary change process works. Working groups meet with the community, school faculty, students, etc. Recommendations are then sent to the person over that particular area to Superintendent Vitti & staff, then to the Board. The Board is working on a template for a school's report card, similar to the student's report cards. She explained that the State is still determined to issue school grades even though it doesn't portray an accurate picture of the schools or our district.

Superintendent Vitti explained the extension for the April working groups. Deadlines were extended for the Board to vote in April but some groups are done and others may miss their opportunities to promote programs such as magnet schools. There are four realities we must address or consider: (1) low utilization, (2) low residency and low utilization, (3) accountability and state sanctions and (4) historically low performances. This will help the community and working groups to better understand the problems so they can create an A, B, or C proposal for the boundary changes.

Brandon Mack, Supervisor, Family & Community Engagement, asked everyone to encourage involvement with Discover Duval & Chat with the Supe. Information on these dates and times are on www.duvalschools.org.

Niki Micheau, Executive Director, Federal Programs/Vasco Eagle and Parent

Advisory Council Chairperson explained what Title I does and how it intertwines with the School Advisory Council and the School Improvement Plan. Goals include trips, enrichments, etc. to help students. Title I provides strategic plans for students in need and schools with 75% low income families are classified as Title I. There are 116 Title I Schools within our district. The Title I program serves public, private and charter schools. Those schools are required to have a Parent Advisory Council (PAC), a School Improvement Plan (SIP) and a Parent Involvement Plan (PIP). The Parent Involvement Plan has a migrant education program as well.

The next District Advisory Council meeting will be Monday, January 25, 2016 at 6:00 p.m. on the 6th floor of the School Board Building. There will not be a December meeting because we feel it is important for our Council Members to spend time with their families for the holidays.

## Minutes:

Essence Duncan, President, Jacksonville Association of Governing Students (JAGS)

I am here on behalf of the Jacksonville Association of Governing Students to discuss our previous meeting held last Wednesday, December 2nd at the offices of the Cathedral Arts Project. Topics during the meeting included an activity on message discipline, a conversation with Dr. Hall, and a report out from our Research Division subcommittee on feedback received on the student code of appearance.

For our activity, we worked as a group in understanding how to determine a stance and develop a message based on a series of vignettes. This activity on message discipline not only gave us an opportunity to understand processes to assist in deciding which stance to take if there is a split decision within the group, but also how to effectively convey the message as well.

Dr. Hall also came to speak with us and solicit feedback based upon some questions being asked during the School Board's listening tours. The conversation allowed us to provide feedback on what we felt was working, what needs to be improved, and what can be done to make improvements. Our organization is interested in hearing the compiled results from the Board once the listening tours are completed.

Our #beheard campaign is in full force. You have probably seen a few of our posters around the building. I wanted to provide each of you with a poster and a card for our campaign. After advertising this campaign and hearing from the student body, our first topic for research will be the district's student code of appearance. Each member of our research division subcommittee has been assigned one of the large Florida school districts so that we can make comparisons and develop a proposal on the current policy in place. Each member has a series of questions they must use when exploring each district's policy such as:

- What is the official and current policy in place?
- Does your district experience any kind of impact to school climate in relation to the rigor of your dress code policy?
- What stakeholders were involved in the creation of the policy?

Our research division is also soliciting feedback from various stakeholders on their opinion of the current Student Code of Appearance policy. We are excited to hear and engage with our various stakeholders, not only within this proposal, but within our campaign as well.
