#### 5. 6TH GRADE CONFIGURATION DISCUSSION

The Board discussed the 6th Grade configuration topic. Ms. Kathy Leroy, Chief Academic Officer, made a brief presentation to the Board. Board members made the following points:

The following points were made in favor of looking further into the issue: empty seats in the elementary schools; reduction in busing; discipline issues.

The following concerns were expressed: would have to limit to schools where space was available and that would lead to inequity; need to look at the Stipulation and Agreement; no access to higher learning materials or athletic facilities; impact on middle schools; discipline is a transitional grade issue and not a 6th grade issue; we have not fully implemented the K-8 concept and need to see how this works before we try another model.

The consensus was to not pursue this issue at this time.
