## Minutes:

- --For our final presentation, I'd like to recognize the students who completed the Superintendent's Leadership Academy.
- --The Academy is produced by the Duval County Council of PTAs to develop student leaders and advocates for public education.
- --In the fall, each high school principal is asked to submit names of up to five students who they believe would benefit from this training and represent their school.

- --The training takes place in our own area high schools and the Schultz Center, on one Saturday each month from October to January.
- --Training topics are presented by professionals and leaders in their respective fields. Some of the topics include group and community building, business etiquette, lobbying protocol and effective letter writing.
- --The Academy trainings lead up to a trip to Tallahassee, where the students speak with members of the Duval Legislative Delegation about public Pre-K to 12th grade education.
- -- Overall, 59 students from 20 high schools completed the Academy this year, which is a total of almost 100 students over the last two years. Many of these students are here tonight. Would the Leadership Academy students please stand to be recognized?
- --Thanks to this program, we are growing some of our future leaders and strong advocates. There is no doubt that these students are now an even greater asset to their schools and to public education in Duval County.

# **COMMENTS FROM AUDIENCE**

### Minutes:

Mr. Edward Exson said for years, public schools have been the citadel for education. Since about 1983, there has been an all out assault on destroying public schools education. Each year since the assault was initiated, there has been acceleration in expediting the demolition of public schools as we know them. Destroyed public schools are jewels and trophies for Right Wing Think Tanks, Conservatives Foundations and the newly formed Tea Party. Trailing behind are so many black intellectuals citing that the educational system has failed, yet few can show any cause, advocacy or fight that they participated in to have adverted such failure. Sponsors of this destruction once were audaciously discreet; now they are supercilious and arrogant with their

desire for charter schools. Those of you that saw when I elicited a respond to a question to the State of Florida Commissioner of Education, the response included a racial epithet. Notwithstanding, the strides made by this Board accelerating pathways fo for all children to succeed, you will face a more difficult time in the future absent of prevailing in a lawsuit, demanding that the Legislature fund public schools, adequately. Not long ago, I spoke from here how some churches breed so many of my people to be a stupid and ignorant fool. In the name of religion, that is laughable. Nothing can demonstrate that more than "Disgraced Megachurch Pastor is back in the Pulpit". "Darrell Gilyard only preaches when no minors are present in the pews, church officials said" which was in the February 5, 2012 Florida Times-Union. It is unconscionable that a family can't worship together by having a felon in the pulpit where the children are barred. By it being "blacks on black" crime, just maybe the State Attorney's office will over look it and give him a pass. In closing, I now understand, Gullah People crying out "Kumbaya, oh my Lord come by here!" Thank you.

Mr. Eddie Diamond, Jr. spoke about black women being stronger than black men. The problem is not failing schools; it is a failing community. We need to change the dynamics of the community. Every successful child stand behind his mother.

Mr. Trey Csar said I am here tonight representing the Jacksonville Public Education Fund (JPEF). I would like to take a few minutes to talk about a few of the initiatives that are under way. JPEF and the Schultz Center will host the EDDY Awards which take place on March 8 to honor our best teachers and announce the 2012 Florida Blue Teacher of the Year. I have heard from the selection committee that this year's nominees were phenomenal! It's a special evening that truly celebrates the profession of teaching and I encourage those who haven't yet bought their tickets to visit www.eddyawardsjax.org. I want to thank each of you for all you have done to support this initiative which is now in its 21st year and continues to grow and evolve to highlight the best practices of our most outstanding educators. Additionally, I want to provide you with a brief update on the ONE by ONE initiative, which is currently in its neighborhood phase. The small kitchen table conversations that form the basis of ONE by ONE have begun, and we are beginning to take the priorities identified in the conversations and categorize them into themes. I'd like to thank all of you for taking the time to see the exhibit and learn more about ONE by ONE. To date, more than 27,000 people have seen the exhibit, including at least 3,000 students who were able to take free field trips and participate in educational curriculum thanks to a grant from Comcast. To date, more than 200 people have participated in the conversations which consist of about 10 people and last about 2 hours. The conversation process is the subject of a story that will appear soon in the Florida Times-Union. We encourage all of you to consider hosting a ONE by ONE conversation in your home, church or any other neighborhood gathering place. The photo exhibition is on display at FSCJ North and the Highlands Library and has received very positive reaction there. It will move to the Beaches are in March. An opening event at the Beaches Museum and History Center takes place on March 2 and we would love for you to attend if you are available. Just as I'm sure you are, we are monitoring closely the developments in the state Legislature regarding the education budget. I encourage you to share our recent policy brief about school funding - as well as information in last fall's ERS report - with citizens you come into contact with, so that they can fully understand the financial situation that the district faces. I have additional copies for anyone who needs more

and it is also available on our website - <a href="www.jaxpef.org">www.jaxpef.org</a>. On behalf of the JPEF board of directors and staff, thank you for all you do for the students and citizens of Duval County.

Ms. Linda D. Kittles said I live in Ribault Manor and this is my second time I've come before you regarding the safety and noise at Ribault High School. They rent out the stadium to outsiders and they blast the speakers throughout the community for hours. We are very tired of this. Would you please do something about this ongoing problem? Thank you.

Ms. Sarah Fowler, representing the Friends of Northwest Jacksonville spoke about Algebra and Biology and significant gains, Educational Directions and our top priority schools - Intervene. Educational Directions monthly report gives unanswered questions. Where are the School Improvement Plans for each school. They do not share the performance of those students. Educational Directions must submit better reports to us.

Mr. John Turner said as you recall, at the close of last month's meeting, several School Board Members took turns congratulating each other and heaping praise on the Superintendent for the great progress that was made in recent years. They boasted and predicted that under the exceptional leadership of the superintendent, Jacksonville will soon be one of the greatest school districts in the nation. All we have to do is stay the course. I hate to throw a wet blanket on your party but I have heard those reassuring promises before. I have heard them over and over again, year in and year out but sadly they never come true. I wish I could really believe you this time but history and the facts say otherwise. Frankly, I'm tired of listening to the School Board mislead the good people of Jacksonville into thinking that our schools are making significant academic strides when in fact we are not. The recent increase in the letter grades of our high schools is due mostly to a change in the calculating formula and not due a huge leap in academic performance. Our FCAT scores remain about the same and that is nothing to brag about. So, just how are we really doing in light of this new inflated grading system where everyone gets points just for participating (i.e., AP program)? Just how do we really stack up to the other High Schools in Florida? I would like to share with you some data from the Florida Department of Education regarding the academic performance of our high schools in Jacksonville. There are approximately 500 high schools in the State of Florida and the Florida Department of Education ranks them all from first to last. I have here a print-out of last page of the rankings which lists the bottom 20 high schools in the state. Did you know Jacksonville has 7 high schools in the bottom 20? If you go to the very bottom of the list you will see that last place is owned by Andrew Jackson H.S. That's right; Jacksonville has the worst high school in all of the state of Florida. That is't my opinion but a fact from Florida Department of Education. Yet, you want us to stay the course!? I say it is time to reverse course! It is time for this school board to get serious. It is time for you to stop making excuses. It is time for you to hold the superintendent accountable. It is time for you to sit down with me and other parents and have an honest discussion so that together we can truly fix our failing school system. Thank you for listening.

Pastor George Harvey, Jr. spoke about sexual predators living near our schools -

Andrew Robinson Elementary, Norwood Elementary and AndrewJackson High. What can the school district do about this?

Ms. Susan Gallo, representing the Cummer, thank the Board for your continual support; Artists exhibit next week and a tour for grades PK-4 through 12th.

Ms. Connie Benham spoke about a bill that came out for the School Board to reduce their salaries on a voluntary basis. Encouraged the Board to do this as you can do better. Please lead by example and take the reduction. Urged the Board not to hire any more cabinet members and downsize the current ones. Municipal Code -Transfer of Property - maps for the north and south banks. Encouraged the Board to sell the property on Prudential Drive and look for occupying one of the vacant buildings near City Hall. This is more than enough to meet your needs. Classes/Portables - School of the Arts Change Orders - all got portables. Twin Lakes Middle School - 1 guidance counselor for 1,000 students while you have 30 cabinet members that make over \$4,000,000 - where are your priorities? I brought to this body visible solutions to drop expenses. I don't expect to know all the laws but once I bring them to you, I ask that this body take them to task.
