Chairperson's Report

[CHAIRPERSON'S REPORT](#)

Ashley Smith Juarez, Chairman, Duval County School Board

I want to begin my report tonight with some congratulations.

Last week, 2015 graduation data was released by the Florida Department

of Education. Every year, it is one of the great honors of Board Members to attend graduation ceremonies. To see the students walk across the stage cheered on by their family and friends is what this work is all about.

And this year, we had the highest percentage of graduates to congratulate in Duval County Public Schools' history: 76.6%; an increase of 2.6% from the 2014 rate and an almost 9% increase over the last three years. These 6,000+ graduates completed all of the state requirements to earn a diploma.

I have invited three principals here tonight to represent the excellence so many schools achieved.

Six schools achieved a graduation rate above 90%: Douglas Anderson, Frank H. Peterson, Stanton, Paxon, Mandarin and Darnell Cookman. Darnell Cookman achieved a 100% graduation rate for the second year in a row.

Eleven schools have earned double digit increases over the last three years: Englewood, Wolfson, Sandalwood, First Coast, A. Philip Randolph, Raines, Westside, Peterson, Lee, Ed White and Mandarin.

Finally, three schools earned double digit increases in a single year: First Coast, A. Philip Randolph and Raines. Under the leadership of Vincent Hall, the class of 2015 at William M. Raines High School earned a 15.5% increase in graduation rate.

I want to congratulate all of the teachers, school counselors, principals, school staff, community partners and parents who encouraged these graduates each day of their K-12 experience. And I want to thank our Superintendent and district staff who have worked diligently to put systems in place to prevent students from falling through the cracks and to promote student success.

Our children are showing up everyday and doing the work AND the adults around them are creating an environment that gives them a pathway to succeed and the assistance they need to keep moving forward on that path.

The graduate's journey does not end when he or she gets that diploma. Those young people are now enrolled in college, technical programs; they are in the workforce; they are neighbors. Some of them are mentoring students working to earn their own diploma.

The upward trend in Duval County Public Schools' graduation rate represents greater potential for growth, development, innovation and civic engagement for Jacksonville. The entire city benefits from these increases. Statistically, higher rates of education result in higher rates of employment, better health outcomes, lower rates of incarceration and greater community involvement.

To those of you who know a graduate individually, you know the pride,

self-confidence and anticipation for a bright future that their diploma brings. So again, thank you and congratulations to all who had a hand in the students' success and congratulations to the 2015 graduating class from Duval County Public Schools.

The Board has continued its work to evaluate the Superintendent's recommended boundary and programmatic changes. Board policies 5.44, School Attendance Boundaries, and 8.51 Academic and Community Excellence Planning Process, define a process for recommendations, community engagement and board discernment.

As a part of the process, the Superintendent first brought recommended changes to the Board. The Board then met in a series of workshops to understand the proposals and work with the Superintendent to devise a time line for deliberation and working group process.

Working groups were formed for each recommendation and included representatives from critical stakeholder groups including parents/guardians, students, school staff, supporting organizations, local community members, civic organizations, and business owners. Six of those working groups completed their work prior to December 8 when the Superintendent brought recommendations back to the Board based on their feedback. Five resulted in recommended boundary and or programmatic changes.

Over the next several weeks the Board will host community meetings to solicit feedback from the community on these five recommended changes. We encourage the public to attend. All meetings will begin at 6:00 p.m. This information also appears on the duvalschools.org website.

The Board is scheduled to vote on the Superintendent's recommendations at our regular February board meeting.

She thanked Dr. Vitti and his staff for providing the resources needed by our schools to accomplish the improved graduation rate within our district. She appreciates the commitment from administrators, teachers, and parents/guardians required in order to help our students graduate. She also reminded everyone of the Martin Luther King parade and Day of Service coming up as well as the activities associated with Black History Month.
