J.P., Student

Ms. Lewis distributed informative information regarding the following:

J.P., a 15 year old student at Joseph Stilwell Middle School was charged with a 4.08 - Possession of a Firearm. On September 2, 2010, a student reported to school security that J.P. had a gun on the bus. Security Officer Brown located J.P. The student removed a .25 caliber pistol and a bullet from his pocket.

Florida Statute 1006.13, Policy of Zero Tolerance from Crime and Victimization, states that each district School Board shall adopt a policy of Zero Tolerance. The Zero Tolerance policy shall require students found to have committed one of the following offenses to be expelled, with or without continuing educational services, from the student's regular school for a period of not less than one (1) full year, and to be referred to the Criminal Juvenile Justice system.

(a) Bringing a firearm or weapon, as defined in Chapter 790, to school, to any school function, or possessing a firearm in school.

The Duval County Code of Student Conduct establishes the School Board's policy on Zero Tolerance offenses. Code 4.08, Possession of Firearms, states that any student who is determined to have brought a firearm as defined in 118 U.S.C. 921, to school, to any school function, or on any school-sponsored transportation will be expelled, with or without continuing educational services, from the student's regular school for a period not less than one (1) full year. (The expulsion requirement is subject to modification, on a case-by-case basis, as allowed by law.) A student who is determined to have brought a firearm to school will be referred for criminal prosecution.

Due to the seriousness of J.P.'s offense and the requirements of 18 U.S.C. 921, to expel students who possess a firearm at school, it is recommended that J.P. be expelled for the remainder of the 2010-2011 school year and all of the 2011-2012 school year with continuing services.

Ms. Lewis distributed informative information regarding L.C.:

L.C., an 18 year old student at Andrew Jackson High School was charged with a 4.08 - Possession of a Firearm. On the morning of November 15, 2010, a private citizen who lives across the street from the school on West 28th Street, called the Jacksonville Sheriff's Office (JSO) to report that she witnessed a student placing a gun underneath the trash dumpster which sits on the campus of Jackson High School. The dumpster was placed under surveillance. L.C. was observed looking under the dumpster several times. He was detained and L.C. admitted placing the gun under the dumpster because he did not want to bring it into the school building.

Florida Statute 1006.13, Policy of Zero Tolerance for Crime and Victimization, states that each district School Board shall adopt a policy of Zero Tolerance. The Zero Tolerance shall require students found to have committed one of the following offenses to be expelled, with or without continuing educational services, from the student's regular school for a period of not less than one (1) full year, and to be referred to the Criminal Juvenile Justice system.

Deputy Superintendent Patricia Willis read the district's recommendation that L.C. enter the Drop Back In program and uphold the expulsion with continuing educational services for the remainder of the 2010-2011 school year and all of the 2011-2012 school year.

Ms. Kriznar stated that there are several locations for the Drop Back In program and we try to place students nearest the home. There is one location at Potter's House on the westside of Jacksonville.

Mr. Hazouri offered a motion to accept the Superintendent's recommendation; Ms. Wright seconded the motion. Mr. Hazouri requested to share what the School Board is recommending to Judge Morrow and stipulate that L.C. will continue to receive educational services. Perhaps, this will help in making his decision.
