- Section 4.3 revise evaluation language 45 days after receipt of the District's FCAT scores delete rest of sentence; Paragraph B should read "in addition, the Board shall conduct an informal performance review during the Board retreat in January of each year; add paragraph for November 18, 2008, evaluation; add language that first year data is benchmark in Section A
- 5.4 add language back that if we change compensation for mobile phones it will be effective for the Superintendent also
