Resolution 10-01: Adopting the 2010-2011 Tentative Millage Rates

WHEREAS, the School Board of Duval County, Florida, did pursuant to Chapters 200 and 1011, Florida Statutes, approve tentative millage rates for the fiscal year July 1, 2010 to June 30, 2011; and

WHEREAS, at the public hearing and in full compliance with Chapter 200, Florida Statutes, the Duval County School Board adopted the tentative millage rates for fiscal year 2010-2011 in the amounts of:

The total millage rate to be levied is less than the roll-back rate by 4.38%.
