Board Member Shine asked what the difference would be in cash revenue with this proposed rate between this year and last year.

Mr. Ron Fagan, Executive Director of Budget Services, reported that last year's Required Local Effort generated \$263,421,113. This year would generate \$261,623,704 which will be less than last year. Board Member Shine asked the question for the benefit of the public so they would be aware that the District will receive less money than last year. Mr. Fagan pointed out that while that is true with Required Local Effort, that is not the case in Capital Outlay, which will be seen when the meeting gets to that point in the budget hearing. Overall the budget is up \$7 million from last year, which is approximately what the inflation rate would be.

Board Member Couch asked if we would be required to share that capital funding with charter school? Mr. Legutko answered that the District would have to share those dollars with charter schools. The low estimate would

be \$16 million. Board Member Couch confirmed with Mr. Legutko that when charter schools close, the buildings they are in do not revert back to our district.

Vice-Chairman Smith Juarez asked Mr. Legutko to explain to the public, in layman's terms, how the Required Local Effort is calculated. Mr. Legutko explained that the legislative process is what determines the rate. That is the rate that must be used by school districts if they want to participate in state funding. He also explained that the rollback rate is determined by the Property Appraiser.
