Board Member Lee was welcomed to the meeting at 5:12 p.m.

Ms. LaTrell Edwards, Chief Financial Officer stated this is the first of two public hearings on the proposed millage levy and budget for FY 2014-2015 and that, as required by law, the hearing was advertised in the Florida Times-Union on Saturday, July 26, 2014. She reported the next meeting is scheduled on Tuesday, September 16, 2014 at 5:05 at the School Board Building. She then read the 2014-2015 Tentative Millage Rate/ Resolution, Tentative Budget/ Resolution, scheduled public hearing on the final 2014-2015 Millage Levies, and Certification of School Taxable Value.

When a motion was on the floor to approve the 2014 Tentative Budget/Resolution the following discussion took place:

Mr. Jason Fischer, Board Member

I just want to say this last year, since February when we started working on this, this is kind of a culmination of a lot of hard work, a lot of meetings that we went through and so I'm proud to support this budget. It's not perfect but it's definitely an improvement upon last year's budget which was also a lot of hard work and a lot of good decisions that were made. But this was definitely an improvement. It continues to shift money from the district office to the classroom; more child centric. It's a budget that better serves children, parents and the community. This 1.7 billion dollar budget creates more opportunities for our children while still protecting the taxpayer by lowering the tax rate. So I support this budget and hope that the rest of you do as well.
