Tonight is my last report to you as president as my two-year term ends on June 15. Thank you all for making this a meaningful experience for me, the teachers, the parents, and students of Duval County.

During the month of May, I attended the NCAA Community Legislative meeting to discuss the options with our three middle schools. As you all know, these schools could face major changes in the future due to legislation sitting on the governor's desk.

Council PTA officers have met with Family and Community Engagement many times over the past two years and we met one last time to assess our efforts in having PTAs in schools. I am proud to report this effort has been a success and this school year, we have re-chartered more PTAs than in years past. This was done in partnership with PTA and Family and Community Engagement. Thank you to Larry Roziers, Brandon Mack, and Tia Leathers.

I attended the Joint Planning Commission meeting with Assistant Superintendent Nelson. I've been part of the principal interviews, I've attended JPEF's One By One conference and was inspired by the speaker. Comments From Employee Organizations

**COMMENTS FROM EMPLOYEE ORANIZATIONS** 

Minutes:

Chris Stovall, President, International Brotherhood of Electrical Workers (IBEW)

After welcoming Dr. Willis back to the District, Mr. Stovall gave the following report:

Thank you all for allowing me to address the Board tonight at what could be my last School Board meeting as a representative of the IBEW. We have our own elections approaching and if I've learned anything about politics in the last year – it's that anything can happen.

I've represented the men and women of the IBEW for quite a while, and about two years ago I began representing the amazing women and men of the Duval County Schools Maintenance, Warehouse, Grounds, and Print Departments.

I've stood at this podium before and bragged to you about how these fine employees consistently knock it out of the park in the yearly national comparison conducted by the Council of the Great City Schools. The

newest numbers are no exception. Despite Duval County Public Schools deferring major maintenance, and not spending significantly on building new schools or renovating existing ones, (we are, after all, in the lowest quartile for spending on major maintenance and renovations, and near the lowest quartile for new construction in America) - despite all of that, these fantastic maintenance people continue to stand out in the areas of cost per work order, work order completion time, and overall maintenance and operation cost per student.

The problem is I stand at this podium and deliver this good news and these accolades for the fine work our employees are doing, [yet] from the previous administration, they hear comments like, "The Superintendent doesn't consider you core personnel" meaning we [the District] can subcontract the maintenance work, if necessary.

I receive emails that say "We have not discussed your proposals (of 3 weeks ago) with the Board yet, so we are cancelling next week's meeting." (Not, we'd like to cancel... WE ARE cancelling). The employees hear comments like "We feel like you are already adequately compensated" despite the fact that the most common explanation given by the employees who leave to find work elsewhere is the wages are too low. I know that several months ago I requested that the District conduct an honest wage study to prove the veracity of its claims of competitive compensation. To this date I have seen no evidence of any action being taken towards that end. But this coming Thursday will be 6 weeks since we met over the ongoing contract negotiations, so maybe they've worked on it since we last met. And, most recently, they are told that, "You will begin working a schedule of 4 10-hour days during the summer months" in Florida - where the average daily high temperature in July is over 90 degrees. The administration has opted to have these employees report to work at 7:00 a.m. and work until 5:30 p.m. Now, given the language of the Collective Bargaining Agreement (CBA) regarding breaks and lunches, those times don't add up properly. Per the CBA, a 10-hour day that starts at 7:00 a.m. should end at 6:00 p.m. with 3 15-minute breaks. But they have been notified that their lunches and break periods would be changed as well - in conflict with the CBA. Whenever I reached out to Board employee in the administration, I was told "You're welcome to come by to discuss - just being honest, there is little, if any, chance this will change." Why is this being done? After all, my office and the administration have had discussions in recent months about changing the summer schedule to start earlier and end earlier for the safety of workers; and to get them out of the hottest part of the day and home safely. So is this change being done to save money by closing the maintenance yards one day a week and thereby reduce electrical and fuel consumption? That doesn't seem likely, since the workers have been divided into crews that will work Monday thru Thursday or Tuesday thru Friday. I have no idea why they are choosing to create a less safe work environment.

But do you want to hear the biggest complaint I am getting from the work force about this change in schedule? It's not the fact that they will be staying later every day. It's not that they will be subjected to more of the intense Florida heat. The biggest complaint I am hearing from employees

is that it will interfere with their second jobs. Because, apparently, even though the administration thinks they are "adequately compensated," a large number of our employees work second jobs to make ends meet.

Now, our CBA with the Duval County School Board states that "Any change in the standard work shift or week will be negotiated with the Union." The administration, however, is resorting to tricks to circumvent negotiations by exploiting a loophole that allows for a "flexible work schedule with a maximum duration of 4 weeks". They are going to change the schedule back to 8 hours during the week of July 4th for one week, and then resume the 4 10-hour days.

I will tell you this--Duval County Schools talks about how they value their employees. They talk about how they value a safe work place. They talk about how they value a good relationship with the bargaining organizations. But these actions don't reflect any of that.

If it comes to pass that I am not representing IBEW members next month, I will miss interacting with these fine brothers and sisters of mine. I will miss representing them in their work place. But I will NOT miss the "Our way or the highway, take it or leave it, do as we say so" attitude that this organization takes with its employees. I will not miss hearing "That's always been a problem here, you won't ever change that." And I CERTAINLY will not miss hearing "You can negotiate all you want, but at the end of the day, the Board has the final say and will do as they see fit, regardless of the outcome of any mediation" (due to nonbinding mediation). If I am looking for a job next month, I can assure you I certainly won't be applying here.

Thank you again for your time, and I sincerely hope that we can get back to work very soon on fixing these problems and making this the top notch organization we all agree it can and should be.

Board Member Couch asked the District to explain the reasoning behind why capital dollars are being spent on a new IT building at a time when House Bill 7069 could make those dollars extremely scarce. Mr. Culbert, Executive Director of Information Technology, explained that the current building they are in is very old and the systems are failing, especially after Hurricane Matthew took its toll. With the new IT building, the District will eventually be able to discontinue the current lease they have at CSX, which would result in the District saving money.

Board Member Couch also noted for the public that our IT department houses student data for the charter schools, with no compensation paid to the public school system. This is another example of the uneven playing field between public schools and charters since it is a cost generated by charter schools that public schools are expected to cover.

# Minutes:

Board Member Couch doesn't see the level of performance with this charter school in other areas of our State that she'd like to see. If the current pending legislation passes, the District would be sharing even more of its resources with charter schools, so she feels they need to become very selective in whom they approve as a charter school.

Vice-Chairman Smith Juarez asked Ms. Chastain about the amount of authority the Board has over charter schools. Ms. Chastain answered that there is not much now and there will be even less later if House Bill 7069 were to pass. Currently, the District can negotiate the charter school contracts with its own terms. If H.B. 7069 passes, they would be required to use the State's standard contract. If cases go before an administrative judge, the losing party would pay attorney fees for both sides.

Board Member Jones asked if board members of the charter schools are required to live in the county where the school is located. Ms. Chastain explained that it is not a requirement of the State; however, if none of them reside there, they must appoint a parent liaison who does live locally.

Board Member Couch noted that the whole purpose behind charter schools was to offer students innovative programming that traditional public schools could not. She wants to clarify that some of the charter school items she did not pull because she could see where they do offer that. This current item on the floor is not one of them. The State does not define innovative programming, which complicates the situation more.

Vice-Chairman Smith Juarez noted that charter schools are not required to demonstrate need to the State before being permitted to build; however, the public schools are put through a rigorous process to demonstrate need before building is permitted. This is yet another example of the double standards set by the State.
