#### Comments From Audience

#### COMMENTS FROM AUDIENCE

#### Minutes:

Ms. Tabitha Cobb said I am an "I'm A Star" student and last year, I stood before you and provided statistics about the homeless population as well as the "I'm A Star" Jacksonville Helps initiative which aided homeless students in Duval County. Despite our success last year, there is still much work to be done and we're hoping that you are ready. Nationally, one-third of the homeless population consists of children. In Duval County, there is a disproportionate number of students that do not have homes. Could one of those students be your nephew, grandchild, neighbor or future employee? Is it your child? No, well, it could be or perhaps one of you would like to offer your child to trade places with one of Duval County's many homeless students. Any volunteers? I'm A Star created Jacksonville Helps to reduce the children's homelessness population and we need your assistance, once again. HELPS stands for Homeless Students Empowered through Leadership Personal Commitment and Service. There are at least 1,900 homeless students in Duval County and we feel that is 1,900 too many. There are homeless students in every school, every School Board district, in every City Council district in Duval County. There are five high schools in Duval County with extreme numbers of homeless students: Robert E. Lee in 5th place with 56; First Coast has 58; Ed White has 60; Terry Parker has 85 and Englewood 100 homeless students. In District I, 246 homeless students; District II, 67; District III 314; District IV, 423; District V, 408; District VI, 246 and District VII, 99 and in our Charter Schools, there are 142 homeless students. This data came from Duval County Public Schools Homeless Education Department. Last year, we raised \$20,000 and presented it to the school district Homeless Education Department. This year our goal is \$50,000 and we will also present scholarships to four homeless students, again. We appreciate all of your help last year and we're hoping for that assistance this year - time, donation or spending the word

about Jacksonville HELPS. It will all go towards a worthy cause. So please, on your ride home ask, "*How Can I Help?*" Thank you!

Ms. Keana Johnson said I'm a rising 12th grade "I'm A Star" student at Darnell Cookman High School and I come before you, today, to discuss our second Jacksonville HELPS initiative. Last year, many Board members helped to promote and uplift our cause to help students in need. This year, we 're asking you to go above and beyond in helping push our efforts forward. We'll have a Talent Show and a Celebrity Basketball Game. Dr. Vitti has been selected to be the head coach for the Celebrity team and the game will be held at Paxon School for Advanced Studies on June 28, 2014 at 6:00 p.m. We are hosting a talent show entitled "*Jacksonville's Got Talent*" and will be held on June 27, 2014 at 6:00 also at Paxon. Please come out and support our cause for our future leaders. We would like you to spread the word within your district. Thank you for your continued support and participation.

Mr. Josh Brown said I'm a rising 9th grader at Paxon School for Advanced Studies. I'm A Star students are comprised of middle and high school students. We may be teenagers but we're also concerned young people and we know we can make a difference. Those 1,900 homeless students need our help NOW. By committing to raising \$50,000, we can provide students with items that many people take for granted: eye glasses, rent, food and many other items. We may be young but we know we can have an impact on the community. Everyone needs a helping hand in life and I am asking you now to support our peers. The Jacksonville HELPS initiative is part of our cause. In closing, we need your donations, publicity and support. Please spread the word about Jacksonville HELPS as well as your time, talent and resources. Thank you for your consideration and we'll be passing out information about our initiative.

Ms. Joan Cooper said I would ask that all of you to please put your cell phones down, turn your computers off and listen to me. That's been a complaint from a lot of people. Things done in the dark will always come to the light. The School Board will go down in history as being weak, uninformed, uneducated and willing to fly with whatever political correctness is current without regard to the actual education of the children of Duval County. That's a dereliction of your duties. I personally feel that the organized group that started the campaign to change the name of Nathan B. Forrest High School and promised, on one or more occasions, to be held to that. I also feel that no changes be made until those donations are received. Our students need that money for education. I also heard, recently, that security personnel are being removed from our elementary schools. In these times of violence, not so sure that's a good choice. I'm appalled that all of you fell under the spell of a few, maybe 10, radical racists. Their campaign of misinformation and outright lies was successful. I really thought that all of you were educated, could do your own research and can make up your own minds. I see that it is not the case. The School Board ignored documented, governmental, historical facts in order to succumb to political correctness of a radical, progressive movement. Their goal is to erase all of Southern history and that is documented on Facebook which is a public thing. It's my opinion that these so-called surveys were eschewed as a result of abundance of misinformation. The surveys of the taxpayers of Duval County were completely ignored. All of the surveys that I saw that were taken, just general things, were totally opposite of what you did. Some of the students voted to change the name after a joke of a panel discussion which I was on, was held in November. It wasn't of discussion; it was just a platform. It was a panel designed to be a catalyst to incite the students of the Negro race at the school by providing them with misinformation. I will

not call them African Americans as I consider that to be an insult to Americans of the Negro race. It was the Africans that sold them into slavery and still do, today. I will send you the rest of my comments, later. Thank you.

Mr. Glen Mallette said the reason I wanted to address the School Board was the disrespect shown to the Forrest alumni in their postings and no responses back in the emails. This issue should have been brought to the attention of the Duval County taxpayers through voting not done solely done by the Duval County School Board since this will affect the pocketbooks of every Duval County taxpayer. The name change process was done in a deceptive manner and handled fraudulently through deceptive practices. This is a waste of taxpayer's money as this money could help students in many other ways. Also, I hope this discredits the Superintendent and the School Board members concerning this outrageous expense in renaming Nathan Bedford Forrest High School. Let the people who signed the petition, along with the School Board members and Superintendent, be held accountable with coming up with the dollars needed for the name change; not the Duval County taxpayers. So far, I've heard only \$3,000 has been collected and that is pretty pitiful. The Duval County taxpayers should not be burdened for footing the bill since this issue should have been put to a vote by the taxpayers and not the School Board.

Mr. Ron Mullins said I attended Nathan B. Forrest from 1959-1965. I'm here tonight to seek accountability for the Superintendent changing the name of Nathan Bedford Forrest High School. There has been zero accountability in the entire renaming process. I'm looking for valid and just reasons for changing the name of this school. The principal at Forrest reached out to the Forrest alumni in September, 2013 with an inspirational letter. He got our attention and about the same time as the letter, the Superintendent's Wolverines smelled blood and went after the name of Forrest and within two months, they sent a petition and gave it to the Superintendent and he began his process to rename Forrest. The entire process took less than three weeks to complete. During the renaming process, there was a closed door session at Forrest where the students and faculty had a chance to vote. They were required to listen to several speakers before voting. During the voting, they were told that the funding to change the name was going to be done by private donors who wanted the name change. Due to this additional information, many voters went back and changed their vote. That is influencing the vote. Since the information about the donors is not true, there was no need for the closed door meeting to take place. The students and faculty should have debated among themselves without outside influence. Any information about Forrest has been swept under the rug. The only reference about the name change is to send donations to help pay for it. They may have raised \$3,000 but the cost is going to be well over \$300,000. There needs to be accountability and detailed expense reports for all changes required for the name change. Currently, the administration, as far as the public is concerned, is working with a blank sheet and a blank check. When money is needed for our schools for extra activities and there is none, think about the renaming of Forrest to appease the Wolverines. If this really is what the principal at Forrest wanted, to burn the bridges with the 55 years of legacy, sentiment and memories, and 30,000+ alumni, there has been no accountability and without accountability, there is no credibility or integrity. The people of Duval County need to demand accountability and a progress report on every issue including the renaming of Forrest.

Ms. Elaine Truett said I want to comment on the Civil Citations. I want to express my

concern with the Jacksonville Sheriff's Department and how they are using the Civil Citations in the middle and high schools. I want to make sure that the police officers are really trained in how to use the Civil Citation. It was amended and it has passed the Civil Citation in Duval County but you all need to know that instead of arresting children, Civil Citations are the best thing to do. In Broward County, they have over 86% of Civil Citations are being used. In Duval, Clay and not Nassau, only 34%. There's something wrong with that. My son was arrested at 12 years old. He never got into trouble after that and he got into JROTC Air Force, he did wonderful and received awards and graduated. He scored high enough to enter the Navy and when they did a background check, he could not enlist due to that arrest at 12 years old. I'm trying hard to fix this so he can enter the military as that is his dream. I'm pleading with you, as a mother, as a single parent and as a widow, as I'm raising my son to do the right thing and be a leader and then this happened. When you decide to put more police officers in the middle and high schools, that you make sure that they are trained and look into the Civil Citations that have been passed by Governor Rick Scott. I'd like to leave this with you as I'm fighting for my son and to do the right thing and serve his country.

Ms. Lyn Corley said at sunset on April 30, 1562, Frenchman Jean Ribault dropped anchor along the North Florida coast near the mouth of the St. Johns River. He was seeking a site for a colony where men and women could worship freely. He also represented the French crown's growing interest to expand his country's boundaries.

As Ribault poetically penned in his astounding account of the visit, "the next day in the morning, being the first of May," he took small boats from his large sailing vessels and entered the river, naming it the River May for the date. The French were greeted by friendly natives who directed them to the easiest landing site. On May 2, Ribault and his men entered the river again and a column was planted in clear view near the river's mouth, claiming the land for France.

Ribault's exploration of North Florida 450 years ago, including contact with North Florida natives, the Mocama speaking Timucua, resulted in a colony at the St. Johns River two years later.

The colony, largely of French Huguenots was officially established June 30, 1564There were many great "firsts" associated with Ribault's visit and the subsequent La Caroline colony at this site.:

This is the site where the first protestant prayer was uttered on what became U.S. soil.
This is the site of the first colony of European men and women seeking religious freedom in the New World.

• Today's Jacksonville is the site of the first recorded birth of a European child in North America.

• The St. Johns River is believed the site of the first international port of trade in North America with the exchange of goods between the French Colony of La Caroline and the Englishman John Hawkins.

• It is the site of the first battle between international powers on land that became U.S. soil – as the French and Spanish vied for power and dominance over North Florida and beyond.

• It is also recognized as the site of the first wine production in North America. By accurate definition, today's Jacksonville is indeed the site of the first colonial Thanksgiving in America. On Monday, June 30, at 6 p.m. in City Hall, the Jacksonville Historical Society, the City Council, the Mayor's Office, major researchers from University of North Florida, representatives of the "Timucua Preserve," Alliance Franciase among others will join together with citizens of Jacksonville to celebrate the 450th anniversary of the founding of La Caroline and the first Thanksgiving in America. I invite you to join on this special occasion.

Mr. Edward Exson said I heard a three-hour talk show on the radio while traveling discussing burying the "N" word. During such time, many callers to me expressed nonsensical, absurd, and irrelevant solutions. Leaving me wondering will the word be resurrected if it were finally died and buried and what new evil, hateful meaning word would take its place? I understand why the word is resented by blacks; it is abhorrent. However, there are both whites and blacks whose conduct and actions are so repugnant that depict the very definition of the word. As the gap crisis is widening, blacks are suffering more profoundly in economic, education, health, justice, wealth and unemployment compounding all the inequality disparities. Most so-called black leaders, politicians and preachers are grossly deceiving us by just talk alone, spending so much time and energy on the "N" word as if they were achieving a major victory discussing it. Yet, not having a clue on developing a strategy uniting our people to work for the better good. While most are totally inept and visionless in dealing with uplifting and empowering people from the ground up in all spheres of civilization. Bringing blacks to work together is not racist; it is being productive and creating a more civilized world. Our circumstances can change with the assurances from knowledge that teaches building, creating, developing, producing that comes from saving and investing. With those assurances, we can truly say, "Yes, we can change our condition." Moreover, those sustainable assurances with a Cultural Revolution transforming us from within that will trump racism and remove any obstacle of hindrance. Absent being involved those assurances, we will continue to drift into darkness and isolation while all people will rise above us regardless of their current status. Dr. Dra, whom is black with a white cofounder of Beats, sold their company to Apple for three billion dollars which should be a lesson to us all. Many blacks opt for a nonprofit business, interested in a high paying director niche which is self-serving, hoping for the possibility of running a scheme as they call it, "getting over". Sadly, many are getting caught and those that are not caught, should be! Thank you.

Mr. Bradford Hall said I wanted to come here to say that I support every public school that is sitting in the heart of our neighborhoods. Nearly, 20 years ago, attended Mary McLeod Bethune Elementary School, a strong hold for the black community here in Jacksonville. There were over 700 students who packed the hall ways and they wanted a quality education. Just about all of my family, my mother, uncles and aunts attended Bethune and they are now in their 40's and 50's. I will never forget second grade where Dr. Bethune's grandson visited our school and expressed how honored he was to have a school bearing his grandmother's name, standing in the heart of a thriving community where the children were plentiful, lawns were maintained and small business owners lived in the community and were successful. I am sure Board members Grymes and Hall can recount these memories as Ms. Grymes was on the School Board and Dr. Hall was principal of another successful community, Martin Luther King. Those were the days and now, here is 2014. In 2014, some argue that it is best to send children to schools operating out of office parks and remodeled crisis centers when there are schools that taxpayers have paid for to serve that purpose. In 2014, where charter school companies

have moved into the center of our community schools feeder patterns and have even walked on a traditional public school campus to recruit students. The administration's leadership and willingness to recognize the importance of offering our students more than a "fly by night" education is beyond reproach and is needed more than ever, before. If we are to compete and keep our community's children in school buildings in their neighborhoods, we require world class principals. We need principals who not only succeed at children passing tests but we require principals who are pillars of their communities. Principals who build positive relationships with all stakeholders and principals who are organized instruction in their delivery of effective leadership. These principals also deserve effective support from district level administrators who have mastered these areas, as well. As long as this system makes decisions in the best interest of the kids, I can tell you we're not always going to agree on all of the issues surrounding education, but as long as we have a system that is making decisions that are in the best interest of children, then I believe that you do have the support of this community. I do believe that is paramount to the success of the school system and every single child. This past week, I had an opportunity to experience the commission and exercises at Ribault High School and I believe that a job has been well done for the past three years under the leadership of the principal. As we transition to a new principal, I hope that we will remember that it is important to build positive relationships, that we go into schools wherever these new principals are going and that they won't make too many changes. They should be committed to building those positive relationships with the community. Thank you for listening and have a great evening.

Ms. Teresa Cluff said I'm here this evening to speak about accountability. As educators, we should all understand what accountability is but for those of you who may not, allow me. Accountability is defined as the state of being accountable, liable and answerable. During the entire controversy over the name change of Nathan Bedford Forrest, the group wanting the name change stated on several occasions there were donations to cover the costs. The proponents of the name change should be held accountable for what now appears to be fraud to sway the vote their way. The school should remain Nathan Bedford Forrest until such time as donations equal total costs of the change. This means \$500,000-\$600,000 to change everything. It is or should be now obvious the name change was not a majority nor democratic situation when one's word can not be trusted. The Superintendent is accountable to the School Board which is accountable to the taxpayers. I challenge the School Board to do what is right in this situation and hold the proponent accountable to their word for donations to cover the costs. I challenge the School Board to hold the Superintendent accountable for the expenditures for the name change and the budget cuts he's wanting to make to the detriment of our students and I promise you, School Board, we will as taxpayers hold each and every one of you accountable for your actions in this situation. Do not play semantics with the taxpayers. The district funds are educational funds; the money is there for funding education, in one way or another. This name change is not an education issue. I challenge you, the Board, to do the competent and responsible action which is to show some integrity and hold the proponent accountable to their word, thereby, not using funds from the district or education funding, not increasing Nathan Bedford Forrest High School's budget to allow the total cost of the name change and if not met, the name change doesn't take effect and they need to be given a tight period in which to collect such funds. Also, not allowing the funds to pass through as whatever to fund the project. It is the right thing to do. This is NOT the taxpayers debt. Lastly but not definitely least, I request the Board to ask for Superintendent Vitti's resignation because as a voter and taxpayer in Duval County, I am very unsatisfied. Thank you.

Good Evening. Duval Councy Council of PTAs ends the year with over 27,000 members. This past year PTAs have provided programing in their school communities in areas of parent education, health and safety, common core, advocacy and teacher appreciation. A few exciting programs were: Frank Peterson PTSA's Stop Bullying Now Parent Program, Atlantic Coast PTSA's Click it Program on seatbelt safety with teen drivers, Paxon PTSA's "Leaving the Nest Program", Terry Parker "Snydertime" and Sandalwood PTSA for their work in advocacy and the list does go on. We want to congratulate Thomas Jefferson PTA, San Pablo PTA, Loretto Elementary PTA, Julia Landon PTSA and Atlantic Coast PTSA for being named PTAs of the year.

This year in partnership with DCPS the Vision Screening program which is in its 42 year had 1,309 volunteers across 156 schools, spent 5,870 hours screening 67,040 students. Of those, 6,786 were recommended for further testing. 216 were found to be legally blind and unable to read the top line on the chart. All but two, had their vision corrected to 20/20 or 20/25 with glasses. Any student who recommended for an eye exam and glasses and has a demonstrated financial need can access funds from DCCPTA's Eyeglass fund which is funded by our local unit PTAs generous donations.

As PTAs transition over the summer the first step to being a recognized PTA for next school year is to go online to FloridaPTA.org and complete the new officer form.

All presidents and treasurers must attend required training. Summer Training Opportunities are:

Comments From Employee Organizations

## COMMENTS FROM EMPLOYEE ORGANIZATIONS

#### Minutes:

Ms. Ruby George, Executive Vice President of Duval Teachers United (DTU), said this has been quite an interesting year and we still have 21 days which equals to 30,240 minutes to go. At 1601 Atlantic Boulevard, we are counting minutes. We have some concerns. Sixty-five security guards will be cut and these have been termed positions that don't touch students. The question is and the answer is that they do impact student learning. No, they do not go into the classroom and teach the lesson but they do impact students. They impact students by making sure the building is clean, children are safe, employees are safe. I do not believe what parents will say that they are not concerned about their child's safety. Not one employee would say they are not concerned about their own safety and I believe you, as well, Dr. Vitti, are concerned about students, parents, your students are in public schools and the safety for all children. Yes, we are all concerned. They were essential this year and they will be essential next year.

At one time, we had a program where every employee, even at the district's office level, was asked to volunteer 1-2 hours per month to go into schools and read or do something to impact learning for children and they did it from this building, regional offices, etc. They were given TDE (Temporary Duty Elsewhere) or volunteered their own time and visited schools. Reading is still fundamental. Even the bus drivers were reading (not when they were driving). It was working and it needs to be explored, again, if we have anyone left to do that. There are some schools that have cars vandalized on a regular basis. Thank you for looking into this matter.

When you think of men and women who touch the lives of children, having been a primary teacher and I was an adjunct professor at Florida Junior College, at the time, you have to teach children at a clean and safe building and the best employees there.

What is going to happen to the aviation program at Highlands Middle School? We received several calls over the past two weeks saying that program will not be there next school year. I don't know if that is true but we need to get information out to the people in that community. If they don't receive the proper information, they'll create misinformation.

We've had many principals that have missed the deadline for April 30 for teacher evaluations and we filed a grievance and they are working their way through the process. We need to let teachers know if they are going to be surplussed as soon as possible as to if they are going to be replaced and moved so we can put some of this unrest to bed and going about the business of why they were hired. Teachers are still saying that we test too much and many of the tests were not relevant for the grade level. We would appreciate your addressing this issue and let's see what happens next year. We are not anticipating a repeat of this year and as we begin to place or replace surplussed teachers, we need to let them know. We know that you can not put them out of field and many teachers are telling us you are asking them to teach out of field.

If you reduce security, you will likely have dark parking areas during the winter months. Will there be adequate lighting in those areas that are not safe? We know that out of those 65 security jobs, they probably won't be replaced, brought back or rehired but we're hoping you'll find the funding to keep them, but if not, what plan do you have in place to make sure these schools are safe? Please listen to us as we have some great ideas and we want to work with you and help you to get it right in 2014-2015. Thank you.

They made the day festive and enjoyable and to thank all of the sponsors, JPEF, Citi Year who helped to provide so many students a great day. It was wonderful to see the number of students attending and the number of schools participating in the bands. I was having fun and I was "stepping" with Darnell Cookman; you missed that.

Gear Up which stands for "Gaining Early Awareness and Readiness for Undergraduate Programs". We have a GearUp program at Andrew Jackson High School and Jean Ribault High School. It is a grant federally funded project that focuses on low income students to ensure that they succeed not just in high school, but in post secondary education. Tomorrow night in this very same room at 6:00 p.m., we will have 48 students who will receive Gear Up scholarships from Jackson and Ribault to sign their awards. There will be \$473,000 given in scholarships to these 48 students, so this is an exciting time. The first school who started this was William Raines High School which just finished its first four-year cycle. Mr. Mungin, the Supervisor, he's writing another grant for the upcoming year to focus on the middle feeder pattern schools.

Save Our Sons - Dr. Vitti and I had an opportunity to share with the Save Our Sons initiative, yesterday at St. Paul Missionary Baptist Church. They have a week long event and yesterday, they focused on honoring, celebrating and supporting teachers. It was a very nice event and many other wonderful events ongoing throughout this week. I certainly appreciate Reverend Guns and all of the partners for understanding and sharing with our teachers because our educational community is very important.

In terms of summer fun, like Mr. Fischer, please get prepared for next year and come back for some exciting news and moves. I just want to up this on the record that the Superintendent is trying to recruit me to play on his team at the I'm A Star Celebrity Basketball Game. That's OK but I'm going to hold back.

In terms of our budget, I'm really concerned about where we're heading with our budget. I'm concerned with the possibility of not totaling looking ahead; every item that we can to ensure that we're doing the very best for all of our employees especially when we're thinking about the possibility of RIF (Reduction In Force) people; it does not sit well with me. I am giving notice that I may request that we revisit any budget item that has already been approved so that if we have to RIF, we make certain that every initiative, project and item is on the table and that we don't have any sacred cows. It is our responsibility that if we have already approved items and now we're addressing RIF and we haven't looked at reducing those items to fit the budget or finding dollars that would be fair to every employee in this district, that we bring everything back to the table and make certain we cover everything. Tonight, I'm serving notice that I may request all or some of those items to come back to us and look at the financial opportunities that we can find within those pots.

Number of graduations: I'd like to end with a quote from one of our valedictorians -Ntami Echeng from Darnell Cookman and I look forward to the day when all of our students can share this type of thought, either in a speech or in their home, communities or in their schools:

"Writing this speech was one of the most difficult things I've had to do in awhile. I paced

back and forth trying to figure out what to say. My sister, Stephanie, was getting upset at me because I was supposed to help her with an essay. So, I sat down and I was prompted by hope from Eleanor Roosevelt that said, 'You must do the things you think you cannot do.' and that's how all of this started. You must do the things you think you cannot do . I hope you dream dreams that were never dreamt before. I hope you live a life unique in its own definition. I hope you're happy. I hope you find beauty in every experience, every adventure and every person you meet along the way, but most of all, I hope you remember to touch the lives of others. I hope that you do not leave here to become a number or a face passing by. I hope you're remembered. I hope you leave a legacy in every step you take and I hope you command standing ovations when you walk into a room."

Ms. Cheryl Grymes said I'd like to acknowledge the graduations. I am continually impressed with the young people we have and they are much brighter and much more philosophical more than I was at their age. I applaud the principals and teachers that organize the commencement exercises as I know it's much work and stress. I was very proud attending Terry Parker's graduation.

I'd like to give a "shout out" (Ms. Marsha Oliver is not here this evening) for the Pep Rally which was alot of fun. Much work went into it and I appreciate the sponsors and partners who participated. I'm very pleased that we have a mascot, DJ and I appreciate what he does and all the staff in the Communications office.

Discover Duval - the last event was held at Terry Parker High School and I thank JPEF (Jacksonville Public Education Fund) for their hard work they've put in throughout the year in organizing Discover Duval. Principal Scott Schneider continues to do a great job and is passionate about his school. They highlighted Dual Enrollment program with Embry Riddle as they were flying drones around the room. Parker is one of those true neighborhood schools.

I'd like to highlight Chartwells who is going to give some competition to the student Food Truck Capstone Project. We have five high schools, Career Academies: Ed White IT Academy partnered with MicroSoft; First Coast Logistics Academy partnered with JaxPort; Ribault Financial Services Academy partnered with VyStar Credit Union; Mandarin Health and Science Academy partnered with Mayo Clinic and Raines Culinary Academy partnered with FSCJ (Florida State College at Jacksonville) Culinary School. They,collectively, over the past school year have been meeting to brainstorm and come up with their Food Truck plan to make this come to fruition. It was most impressive hearing them actually pitch their business plan. It's hard to believe these are high school students and they're trying to raise \$75,000. This has been a huge learning experience working collaboratively with the Chamber and Big Brothers and Big Sisters. I'd like to give a "shout out" to Andrew Post as I believe this project was his "grandchild". I appreciate all of your work as it is a true example of project learning.

I'd like to thank Pam Pierce, principal at Spring Park Elementary School, regarding the 5th Grade Graduating Ceremony. I attended this ceremony as my "little sister" with Big Brothers Big Sisters attends that school and we've been together since she was in kindergarten. Their program was delightful and all of the students were very dressed up. I know alot of work went into this ceremony and it was great.

I want to thank all of our teachers and hope you get some rest and relaxation over the summer. I applaud your calling in being a teacher as I could not do it and I'm grateful for those who do it. I was to give a "shout out" to the principals and staff, as well!

Ms. Ashley Juarez said I'd like to congratulate all of the graduates, 5th graders rising to 6th grade, 8th graders who will enter the 9th grade and all of our seniors who will be entering a variety of paths for the future but each with a Duval County Public Schools diploma in hand. Those ceremonies are all a thrill and a delight to be part of and the fact that they are each, in some part, designed by the students, and the students have their own thumbprint on what they like and move forward is fun and a reflection of the hard work that they have done and the preparation they have made for their future. I'd like to thank school faculty, staff and district personnel as there has been much change this year and I appreciate all of them as they continue working diligently every day for all students.

This was a year of "firsts" at several of the high schools in District III. I'd like to recognize the students at Alden Road who are involved in the Business Enterprises. It is a tremendous program and the products that these students produce for the market are remarkable. Englewood graduated their first Early College students and so those students will be leaving high school with not only their Duval County Public Schools high school diploma but also an Associate of Arts (AA) degree from Florida State College at Jacksonville. Wolfson had it's first graduation for their International Baccalaureate (IB) candidates and these students will be leaving high school with an Advanced Diploma that can be applied with two years of college credit. Sandalwood, the first AVID group to graduate with National Model status along with their Early College graduates; it's just the third school in the nation to earn that status which is incredibly impressive and speaks to the diligence and persistence of the team at that school. I'd like to speak on behalf of Board Member Fel Lee who is not present as I attended the Fletcher graduation and the first cohort of AICE students graduated. It's been an exciting time for many of our students and the degrees they have earned that will serve them well.

Learning should continue over the summer whether in a formal setting or at a park, library or going to the Cummer Museum. There are many opportunities from going to the grocery store to attending some of our cultural institutions that can become learning experiences for students. I encourage parents, care givers, community partners to continue that strong work over the summer with students.

Dr. Constance Hall said congratulations to James Weldon Johnson Middle School for your 27 students receiving the Perfect 6 on the FCAT Writing portion. I recall being at J.W. Johnson when we had 36 students that received the Perfect 6. At the end of the celebration, the teacher asked, "*How are we going to continue this?*" The very next year, over 98 of the students received the Perfect 6. So, J.W. Johnson with your 27, congratulations and let's double it next year. *Go Trojans!* 

Paxon High School - 300 graduates, over \$10 million dollars in scholarships, two appointments to West Point Academy; one appointment to the Coast Guard Academy; one appointment to the Merchant Marine Academy and one accepted into Harvard.

Frank H. Peterson - 208 graduates, 40 Honors Diplomas, \$658,110 dollars in scholarships, 109 students received an Industry Certification and 16 students received the State Merit Diploma Designation.

The Nathan B. Forrest graduation marked the end of an era. The 55th Commencement Ceremony was the last under that school name. Next year will mark the first Commencement of Westside High School. The last Rebel standing had some remarkable achievements. The 270 graduates took over 600 AP and AICE exams and earned more than \$750,000 dollars in scholarship money. Over 65% have planned to further their education or join the military. In addition, it was a special occasion to honor the following student:

Zachary Willis who would have graduated in 2014 and it was touching to watch the graduates and the faculty honor his memory and the parents, as well.

Raines High School with 200+ graduates and a National Merit Scholar.

The Bridge to Success honored their graduates at Atlantic Coast High School in a very outstanding ceremony and we know how the Bridge to Success started and how great it was to see those students reach that part in the lives and be able to graduate. We know that at the start of the next school year, there will be a smooth start and they'll need a larger venue to hold their graduation.

My favorite was Palm Avenue. There was a student that during the course of the year would not get out of the car until she was ready. She would get into those moods at times. During graduation she didn't want to get out but during graduation, towards the end when they called her name, who rushed down the aisle with the biggest smile you've ever seen, up on the stage and if you've ever seen the Rocky movie, there she was, holding her diploma as if she had won the race - it was so exciting and that kind of enthusiasm let's us know why we do the work that we do. It's lets us know we must work harder so that all students can reach that point in time in their lives to feel success and to be successful.

I want to wish all staff, our parents, our partners a very happy and safe summer and be sure to read, read and read! Thank you.

Ms. Becki Couch said I'd like to commend the district for the Pep Rally. I think it was a great event. I had a great time and I believe it gets better every year.

We had alot of faculty here this evening from Joseph Stilwell Middle School and Jason Bloom, principal, brought some members of the faculty. It was on the agenda this evening that we're going to be adding at the school, a magnet for military leadership. That will begin the 2014-2015 school year. It's been very exciting and the Superintendent and I have spoken with the community about this idea and we have the support that is needed. I feel it will be well embraced on the westside of town. We are currently looking for students to apply, 6-8 grades. You may contact the School Choice Office (390-2144) for applications.

I had the opportunity to attend Chimney Lakes Elementary as they are a multi-cultural magnet school and they held a festival. I was blown away and wish I had a news crew with me to show off every thing the students worked on. It was better than the World of Nations. Every hallway was decorated with the projects the students did all year long. Each grade level chose a country to study. Many parents and partners attended the

event. There was no cost to the school as the partners support the school. It was so great seeing so much support for this elementary school. Words can not express how proud I was of the students, faculty, parents and volunteers - that is what great public education looks like! I hope we'll have some coverage next year so that the public can see what great things are ongoing in our schools.

I attended a luncheon with the Superintendent and Board Member Cheryl Grymes to celebrate the partnership that the Logistics Academies at Ribault and First Coast High Schools have with JaxPort. It was on the Carnival Fascination ship before they set sail and it was so exciting and great event. The kids attended and chose to have a formal dinner along with a scavenger hunt. It was a great opportunity for the students and me. Thank you Big Brothers and Big Sisters for your partnership.

Several of us attended the 5th and 8th Grade Graduation Ceremonies. I'm looking forward to those becoming bigger and better over the years. It was so heartwarming to see so many parents show up, particularly at the 5th grade at Lee High School. It's a good thing to see people sharing the success of our students. I want to thank the district for putting that together and acknowledging the hard work that our 5th and 8th graders did in the top 5%.

I want to commend the district for all of the graduations I attended. Lee High School had 40 students graduate with an AA degree. That is so amazing to me and I wished I had that opportunity as a high school student as it would have saved my parents alot of money. I don't think we really tell our story as we have so many opportunities for our students to go beyond high school while they're within the walls of our buildings and experience college which helps parents save alot of money. Most private schools can't say they can do that for students and we're beating the competition in that arena.

I do want to mention that we are getting a new test for Common Core, Florida Standards whichever the new name will be. Several things are being worked out and it will have an impact on our students. Parents should be made aware of that. 5th grade will be on a computer with writing which is something we've never experienced, before. 11th graders will need to type their essay on a computer, as well, in a time limit and many of us may struggle with that, especially, if you don't have access at home. I think it's important for parents to understand what is happening and to be more vocal. You can contact your state lawmakers, contact us and learn what is happening and we will share this information with parents.

I'd like to ask Mr. Fischer, "Do you have a real estate agree for this building?" We're definitely looking forward to that conversation, later. I don't think that any of us against that idea.
