ASA PHILIP RANDOLPH ACADEMIES OF TECHNOLOGY

Minutes:

Robert Lewis, Principal, A. Philip Randolph Academies of Technology High School

Mr. Lewis gave background information on A. Philip Randolph Academies of Technology High School and the four areas of study they offer through a PowerPoint presentation (see attached). He reviewed the progress the student body has made in recent years and how they arrived there. The projected graduation rate for 2015-2016 is expected to reach 98%. He then discussed how they expect to reach that percentage.

#### RECOGNITION - COMMUNITY PARTNER JACKSONVILLE ZOO

Minutes:

We begin by recognizing a community partner who assisted the Parent Academy with its annual event in November, which is also Family Engagement Month. The generosity of the Jacksonville Zoo and Gardens allowed this year's event, "Wild About Family Engagement," to be the most successful event in Parent Academy history. Over 383 parents and 688 children gained free access to Jacksonville Zoo and Gardens. Families enjoyed lunch, and participated in giveaways and a Scavenger Hunt, while seeing the over 2,000 rare and exotic animals and 1,000 varieties of plants on display. For many of the adults, this was their first time visiting Jacksonville Zoo and Gardens. The experience was that much more enjoyable because it was done with their family. Duval County Public Schools thanks the amazing staff at Jacksonville Zoo and Gardens for not only ensuring that this event was "WILDLY" successful, but for also giving a number of families this opportunity.

## **RECOGNITION - TEAM NEON SUPERNOVA**

#### Minutes:

We now wish to honor six middle school students from three schools who reached great heights at a robotics competition. Team Neon Supernova is comprised of James Weldon Johnson's Aryaman Deshmukh, Saniya Kulkarni, and Siya Sharma; LaVilla School of the Arts' Caroline Guiler and Blake Larsen; and Fletcher Middle School's Emily Merkel.

These six students actually competed together as a robotics team in elementary school. Even after going to different middle schools, they decided to stay together as a team.

In January, Team Neon Supernova went up against 31 other elite robotics teams from the region and emerged victorious at the FIRST LEGO League Robotics Competition held at the University

of North Florida. The team earned the Champion's Trophy for Northeast Florida, a special tour of the Mayo Clinic's Robot Medical facilities, and an invitation to the LEGOLAND California Open Championship May 19-23. The team has since been fundraising to cover trip costs, and make improvements to their robot in order to represent Northeast Florida well in California. Please join us in congratulating the six members of Team Neon Supernova along with Coach Brady Merkel, Assistant Coach Kim Larsen, and mentor Mark McCombs.

## **RECOGNITION - UNSUNG HERO BRIAN TATE**

#### Minutes:

Our next presentation recognizes someone who is the true definition of a hero. Brian Tate is a Communities in Schools of Jacksonville Site Coordinator at Arlington Middle School, and is deeply committed to fostering a love of reading in the students he works with. Many of his students have struggled with reading, which impacts their performance in other classes. On top of that, they're not always able to find time in between classes to check out books from the library. As a result, Mr. Tate checks out books for his students and delivers them to their classes. Last year, 99 percent of his 170 students passed their reading/language arts class and 98 percent were promoted to the next grade level.

In January, the Communities in Schools National Office recognized Tate with the Unsung Hero Award at their 2016 Town Hall Leadership Conference in Fort Worth, Texas. This award honors site coordinators, schools, and communities across the country for doing whatever it takes to help students achieve. Here to help honor Mr. Tate is Communities in Schools' Steve Gilbert, Leon Baxton, Dan Gilbert and Erin Mangan; and Arlington Middle School Principal Yolanda Sanders.

#### RECOGNITION - STATE VOLUNTEER AWARD WINNER AMY MITCHELL

## Minutes:

Now we recognize a volunteer recently honored by the State. In February, Ms. Amy Mitchell was named the 2015-2016 Outstanding School Volunteer for the Adult Category of Region 2 by the Florida Department of Education, and Commissioner of Education Pam Stewart. This prestigious award recognizes outstanding volunteers at the youth, adult, and senior levels, who have demonstrated exceptional dedication and commitment

to quality education.

Earlier this school year, Ms. Mitchell was named the district's Outstanding School Volunteer for the Adult Category. She has been a volunteer at Holiday Hill Elementary School for the last four years, and has compiled over 500 volunteer hours providing support to teachers, serving as the PTA secretary, and serving as the Morning Mile Chair. As the PTA secretary, Ms. Mitchell responds to parent and staff questions, and provides regular updates about school activities. Ms. Mitchell also wrote and received grant money in order to launch the Morning Mile program at Holiday Hill. By the end of last school year, approximately 70 percent of students had participated, logging 13,500 miles. Joining her are Assistant Superintendent of Family and Community Engagement, Mr. Larry Roziers, and Holiday Hill principal Tammy Haberman. #### RECOGNITION - JACKSONVILLE EQUESTRIAN CENTER ART CONTEST

#### Minutes:

For our final presentation, a community organization is expressing its gratitude to the district for helping make its event successful. Duval County Public Schools teamed up with the Jacksonville Equestrian Center and the Northeast Florida Equestrian Society for the first ever "Take It To Jax" Agricultural Art Contest. Artwork had to be agricultural and the artist needed to think outside the box. A total of 122 outstanding entries were received from seven Westside Elementary Schools – Chaffee Trail, Chimney Lakes, Crystal Springs, Enterprise Learning Academy, Mamie Agnes Jones, Normandy Village, and Thomas Jefferson. Chairperson's Report

**CHAIRPERSON'S REPORT** 

Minutes:

Ashley Smith Juarez, Chairman, Duval County School Board

As usual, the Board has been very busy. Typically the Chairman's report reflects on the last month's work of the Board and gives a preview of upcoming work. However, tonight I want to give a longer-term reflection.

The recent sidebar conversation has been allowed to become the narrative of our work. I want to remind each other, DCPS staff and the public of the many collaborative projects this Board and our Superintendent have undertaken and the accomplishments of our collective work.

Vice-Chairman Paula Wright serves on the Executive Committee for the Council of Great City Schools, a National Advocacy organization that had a strong voice in the reauthorization of Title I allowing DCPS to retain millions of dollars that are directed to serve the needs of children from low-income households. We have debated and decided upon strategies to direct those funds to their best use for children with economically challenged life circumstances.

Board Members Couch and Fisher have drafted a resolution and a letter, respectively, to advocate for a fair and efficient state accountability system. The resolution drafted by Ms. Couch addressed the need for a baseline year as Florida shifted to new standards and a new assessment. The letter drafted by Mr. Fisher called for consistent assessments and the opportunity to use nationally normed tests for accountability, something that has raised much discussion during this legislative session. Both the resolution and the letter were unanimously adopted by the full Board.

Dr. Connie Hall worked with the Superintendent and the Eugene Butler community to envision a new learning environment and more specialized programming for that middle school. The dedicated magnets Young Men's Leadership Academy at Eugene Butler and the Young Women's Leadership Academy at Eugene Butler have transformed school culture and are growing into formidable programs for the students they serve. Again, this transformation earned a unanimous vote of the Board.

Most of us voted for (and I only say most because Mr. Shine was not yet here to vote) and all of us have overseen the implementation of two Qualified Zone Academy Bonds (QZAB) to greatly expand broadband access and the hardware, tablets and laptops, accessible to students. Technology is part of learning and will certainly be a fixture in the 21st century workforce. I applaud the Superintendent for finding the community matching dollars necessary to leverage these bonds and for bringing the opportunity to the board.

We, together, voted to make a \$16 million dollar investment to renovate and expand Douglas Anderson. Increasing classroom capacity, providing a cafeteria where all students can be served, sit and have lunch and upgrading hands-on learning environments were all a part of that extensive project. We also expanded the arts district-wide by ensuring an art and music teacher in every elementary school and expanding arts programming at many middle schools.

We have maintained a commitment to student exposure to the global economy. We insisted on continuing to require foreign language credits of our graduates even when the State does not. We have expanded our Dual Language programs, lengthening the continuum to middle school and tonight we will vote, currently as part of the consent agenda, to add a Bilingual Certification to the diploma of students who qualify.

The Superintendent and staff have pursued grants to expand our capacity to provide mental health services and social and emotional supports. The Board has applauded and adopted these opportunities.

I could keep us here most of the night with examples of the cooperative, deliberative, sometimes contentious but always intentional work we have done at the Board table. And there is much more of it to do. Let me assure the public that this Board and our Superintendent understand that we have a huge obligation to children and to the greater community.

We do not have time nor should we spend our energy engaging in conversations that distract from these efforts. I welcome the tough conversations, as I know we all do, about student achievement, school organization, positive school culture, and community engagement. We have come a long way but we still have a long way to go. We recognize that; it is why we are here.

The work of urban school Boards is messy. This work is inherently difficult and requires debate. We are charged to innovate but not experiment; reform but not exclude; advance and remediate; expand and be efficient. We represent diverse constituencies and diverse learners. No child has time for us to wait. I am not lamenting the work. On the contrary, I am realistic about the work at hand and I know that my colleagues, our Superintendent, and I will continue rising to the challenge.

We have big challenges and even bigger goals for all children. The Board and our Superintendent share an urgency about getting to the issues.

Our relationships and trust are important to our work and we will continue working on our development as a Board/Superintendent team.

After years of work with the Board Members to my right and left and with our Superintendent, I know we are capable of rising above our disagreements and focusing on the work at hand. We have done it before and can do it again. The choice is ours.

## Stanley Scott

Mr. Scott spoke of his concern about the educational climate both throughout the district and within the classrooms. Leadership is appalling and teachers are afraid to teach for fear for their lives. Grades are not the indicators they used to be. Students can get straight A's in high school, yet fail in college. There is a moral compass that is missing as well as community engagement. He plans to return later with a proposal.

Darrell Edmunds, Teacher, Alden Road Exceptional Student Center

Mr. Edmunds explained problems that have arisen with the center school supplement that was intended to boost retention of teachers. Some teachers did not qualify for the supplement due to circumstances beyond their control. Since other schools that teach disabled students probably have the same problem, he asked the Board to review the policy that oversees center school supplements.

## Eunice Barnum, Advocate

She thanked the Board for the successes the district has had. She also wants to address what has not been accomplished. After reminding the Board of the oath they took and district motto, she asked how the Board is choosing who they leave behind since they have until 2018 to have all children proficient.

#### Edward Exson, Activist

Mr. Exson opined that the friction among the leadership in our school district is race-based.

## Bradford Hall, Activist

Mr. Hall noted for the Board the hypocrisy of one board member running for office accepting campaign donations from a known racist while demanding the resignation of a fellow board member for making disparaging remarks. He is disturbed that data from the State paints a different picture of the state of our schools than the data from our own district and hopes the two can collaborate to arrive at compatible numbers.

Ms. Tookes encouraged the Superintendent and Board to consider the recommendations and timeline suggested by the Fort Caroline working group.

## Ferdinand Juluke, Grandparent

Mr. Juluke commended the Board and Superintendent for allowing the Fort Caroline working group to look at what needed to be resolved and allow the group to think outside the box to make recommendations. He asked that the Board consider the group's recommendations when deciding on the changes affecting the Academies.

## Doris Wilson

Ms. Wilson voiced her disgust at the behaviors of the district leadership and reminded everyone that our leaders have a right to disagree but can still work together for our students.

Sabrina Zinamon, Parent & Chairman, District Advisory Council

Ms. Zinamon encouraged the Board and Superintendent to remember the importance of working together in unity for the education of our children.

Melissa Carnard, Parent

Ms. Carnard voiced her frustrations over calls not getting returned and concerns not being resolved.

Katie Dearing, Parent

Ms. Dearing is frustrated over all the time, money and attention being directed at the struggling schools; meanwhile, the bright students at the "regular" schools are being overlooked.

John Nooney, Advocate

Mr. Nooney encouraged the Board to consider making a land donation for a kayak launch available to the public.

Jeremy Kowkabany, Student, Stanton High School

Mr. Kowkabany asked the Board to consider purchasing land adjacent to Stanton High School that could be used as a practice field for the football team.

Bettye Miller, Advocate

After listing desirable leadership skills, Ms. Miller opined that the district leadership can't continue to lead by throwing potential solutions out in hopes that something will work to improve our students' education. If a leader has the skills necessary to do accomplish a mission, a coach shouldn't need to be hired.

February has been a busy month for us. We had 44 high school students complete the Superintendent's Leadership Academy. These students give up their Saturday mornings to attend classes on business etiquette, leadership styles, public funding of education, and meeting with decision makers. This program culminated with a trip to Tallahassee where the students spoke of their concerns regarding public education to their State representatives and Senators. The School Board recognized them at the February school board meeting with proud parents in attendance.

We have conducted an email campaign to our State legislatures regarding recess time for our students. We asked each local unit of PTA to take time out of their meetings to email at least one member of the Duval Delegation asking them to support the recess bill.

The Council of PTAs has also been visiting and assisting schools with local

unit PTAs, helping them conduct elections, advising on member goals, and helping resolve conflicts. We currently have 87 local unit PTAs in good standing and are working with quite a few others to achieve that goal. We have rechartered Gregory Drive Elementary PTA and we have met with interested parents and faculty about restarting the PTA at Matthew Gilbert Middle School. We've recognized our past presidents on our Founder's Day meeting and thanked them for all the hard work they have done on behalf of PTA and the Duval County Public Schools. We have volunteered at the Teacher Supply Depot for the Teacher Give Away Days. We have served on the committee that interviewed and helped choose the Teacher of the Year for the upcoming EDDY Awards and we have participated on the committee interviewing for principals and assistant principals.

March is shaping up to be another busy month as we assist all local unit PTAs, helping them finish the year strong, nominate new slates of officers, and prepare for Teacher Appreciation events.
