Topics To Be Discussed

1. PRESENTATION BY DON MCADAMS ON SCHOOL REFORM & SCHOOL BOARD & DISTRICT EFFECTIVENESS

Minutes:

Board Vice-Chairman Nancy Broner introduced Mr. Don McAdams, Director of the Center for Reform of School Systems.

Mr. McAdams addressed the group on governance and the pros and cons of a mayoral controlled school Board. Some of the points he made were:

- As a rule, mayoral control is only a temporary action and even then only when a district is in crises.
- Mayoral appointed Boards tend to make citizens feel shut off and they do not know who their Board Members are and how to reach them with concerns.
- Districts with appointed Boards were discussed.
- The least desirable scenario is half appointed and half elected.
- Democracy is the citizens having the right to elect their representatives and having control of their public schools.
- It is essential that the public feels they own the public schools.
- You have more transparency with an elected Board.

During a question and answer session, the following points were discussed:

- When asked how he viewed Duval, Mr. McAdams responded that Duval has a very good reputation around the country.
- Board Member Burney pointed out that our District has a grade of B from the

State and that is above average.

- When asked about selecting Board Members from a single district or at-large, Mr. McAdams responded that at-large were preferable, whether appointed or elected.
- Mayor's have the same pressures as an elected Board.
- Correlation of funding vs. student achievement depends on how you use the dollars.
- Pitfalls to be careful of when implementing programs: what is taught; how well it is taught; how long it is taught; changing strategies and not staying with a program long enough for it to show results.
- Avoid fad programs i.e., smaller classes; across the board pay for all employees; small schools.
