1. FINAL ORDER RE: DUVAL COUNTY SCHOOL BOARD V. DONNA JAMES

Minutes:

Ms. James was charged with failure to adequately supervise students under her direct supervision on numerous occasions, including without limitation: (1) leaving two first grade students on a playground while taking the rest of their classmates back to class; (2) permitting a kindergarten student, who was not a bus rider, to board a school bus; (3) leaving her classroom unattended, during which time one student stabbed a classmate; and (4) failing to adequately supervise her classroom so as to prevent two students from engaging in a sexual act.

In his July 23, 2013, Recommended Order, the Administrative Law Judge concluded that these charges were not supported, and in the

recommendation on page 19 of the Recommended Order, he stated: "...That a final order be entered by the Duval County School Board dismissing all charges and rescinding the termination of Employment contract of Donna James for the reasons set forth above."

Mr. Harold Lippes, attorney for Ms. James, presented her case to the Board.

Mr. David D'Agata, Office of General Counsel, presented on behalf of the school system.

2. FINAL ORDER RE: DUVAL COUNTY SCHOOL BOARD V. SHARON SANDERS

Minutes:

This case arises from the District's decision to reassign Sharon Sanders from the position of Principal to the position of Assistant Principal, with a corresponding adjustment in salary. The District's Notice of Discipline indicated that Ms. Sanders directed staff to violate testing protocols related to the administration of the FCAT writing test, and that Ms. Sanders subsequently failed to report violations that were known to her at the time of the administration of the test. Finally, the District alleged that Ms. Sanders made inappropriate comments to staff regarding the investigation of the reported violations.

The Administrative Law Judge concluded that these charges were not supported, and in the Recommendation on page 92 of the recommended order, he stated: "...That the Duval County School Board enter a Final Order dismissing the Notice of Discipline in its entirety."

Mr. Tad Delegal, Attorney for Ms. Sanders, presented her case to the Board. A copy of his PowerPoint is attached to the Minutes.
