Miss Richardson feels she is getting a strong education through public school system.

Debbie Kane, Parent, Crown Point Elementary Crown Point dynamics have changed over the years. It is now one of three ESOL centers for elementary schools in our county. The language barriers for these students present many challenges. Each ESOL class in the past has had two teachers. Due to lack of funding, they now only have one. All students--not just ESOL students--are in dire need of reading assistance. The school still doesn't have the reading interventionists it was promised. She asks that the Board look into the lack of staffing

Lou Nussbaum, School Counselor, Crown Point Elementary School There is a lack of equity among schools and should be a concern to the Board. Areas at Crown Point lacking in resources:

- 1. Guidance one counselor for 1043 students. Average ratio in the county is 550:1
- 2. Only Title I schools have received the full or half time reading specialist promised to each school.
- 3. The school has asked the district with help with overcrowding issues, with no response.

Board Member Hall - The Resolution to withdraw support from FSBA lawsuit is a distraction from our goals.

Board Member Wright - The Resolution does not oppose a parent's right to school choice, it is a constitutional issue. Board Member Fischer - He has consulted with counsel; there is no conflict of interest with him; he works for an engineering firm, they are not in the business of education. The real conflict of interest is FSBA/unions using taxpayer dollars to sue the State and selfishly increase their assets and deny low income families an education. We pay thousands of dollars every year to participate in FSBA activities, we have someone who is on the Board of Director and at least one officer voting in favor of the lawsuit. FSBA is supposed to represent all of us and we have at least 5,000 families who would be hurt by this lawsuit. Courts have determined tax credits are not government expenditure. This will result in a frivolous lawsuit, wasting taxpayer dollars. The Resolution has been reworded to indicate a withdrawal of support from the lawsuit and does not reflect a specific standing on the scholarship program.

Board Member Smith Juarez - Thanked Board Member Wright for clarifying to the public that the Board plays no part in administering the tax credit scholarship. She agrees with Board Member Hall that the Board needs to stay focused on providing

high quality education to our students.

Chairman Couch – Researched position statement of FSBA; they support charter schools but feel they should be subject to the same accountability standards as public schools since they are receiving taxpayer dollars.

2. <u>RESOLUTION IN OPPOSITION OF THE FLORIDA DEPARTMENT OF EDUCATION'S INTENT TO ISSUE SCHOOL GRADES FOR 2014-15</u>

Minutes:

Chairman Couch gave some background information on the Resolution:

The resolution was drafted in partnership between the Board and Superintendent and staff. It is on our legislative agenda. It asks that there be a one year baseline year where we are held harmless which I understand is the case with sanctions and punitive matters; however, we will still be given a school grade

based on a test that has not been properly field tested. Students who have never been trained in keyboarding skills will be tested on the computer. Is that fair? This test will determine a lot of things for students such as the high school they attend, program they qualify for, etc. The FCAT was rolled out and didn't count for at least three years. Why is this one different?

Board Member Fischer - most of the Resolution he is in agreement with. Superintendent Vitti clarified that sanctions are not planning to be withheld during this transition year like it was when FCAT was rolled out. Board Member Fischer's biggest hesitancy is requesting that no letter grades be given out; that requesting sanctions be withheld this year is a fair compromise.

Chairman Couch – The Resolution will make data available to parents but parents will judge a school based on the letter grade on it. We have started a race this year without knowing where the finish line is.

Board Member Fischer wonders if this is to help children or try to deal with public perception. Superintendent Vitti said the direct sanctions would affect adults more than children but the indirect sanctions have more of an effect on children. The Resolution indicates a support to publish all the data. Board Member Fischer feels not publishing the school's letter grade would not be publishing all the data.

Board Member Fischer made a motion to amend the Resolution.

Board Member Lee – At some point we have to get all public money that is spent to have the same criteria—period. Then we don't have these discussions anymore. There are publications that compare both public and non-public schools. Yes, they do use school grades and parents look at other data when considering the non-public schools so there could be an argument either way. It's a perception issue on all sides.

Board Member Hall would be proud to have this Resolution go out from this district. It's taking a stand on something that has been done haphazardly for years. Is this the actual Resolution that came out of workshop?

Chairman Couch passed the gavel to Vice Chair Grymes to make an amendment to the item as it is worded on the agenda. Board Member Lee noted we will never have the community's full trust without reasonable but fair accountability standards. This vote is not about getting rid of accountability, it's about getting it done the right way. Board Member Wright – this is our opportunity to state that we want fairness in accountability, not just in Duval County, but across this great State.

A RESOLUTION MEMORIALIZING THE OPINION OF THE SCHOOL BOARD OF DUVAL COUNTY, FLORIDA AND THE SUPERINTENDENT OF SCHOOLS IN OPPOSITION OF THE FLORIDA DEPARTMENT OF EDUCATION'S (FDOE) INTENT TO ISSUE SCHOOL GRADES IN A TRANSITION YEAR FOR STANDARDS AND ASSESSMENTS AND CONNECTING THE RESULTS TO STUDENT PROMOTION AND RETENTION AND TEACHER AND PRINCIPAL EVALUATIONS.

WHEREAS, The Duval County School Board and Superintendent of Schools support and commend the FDOE's implementation of new standards and the full testing of students on the new assessment in 2014-15; and

WHEREAS, a fair, valid, and reliable state accountability system is required and supported by the District to ensure that all students are prepared and inspired to ensure success in college, workforce, and life; and

WHEREAS, the FDOE has not properly field tested the new assessments creating a scenario where it is statistically irresponsible to implement any form of school grades without a baseline year to determine learning gains; and

WHEREAS, 32 changes to the accountability system over the last three years and the prevention of school grades being reduced by more than a letter grade has led the public to lose confidence in the school grading system; and

WHEREAS, the FDOE did not release item specifications for the new assessments until a few weeks prior to the start of school thus limiting professional development, adjusted district progress monitoring tools, and curriculum decisions; and

WHEREAS, the Gates Foundation has publicly supported a two-year moratorium on tying results from assessments aligned to the new standards to teacher evaluations or student promotions; and

WHEREAS, the United States Secretary of Education, Arnie Duncan, has allowed states to postpone tying student achievement to evaluations for one year for states implementing the new standards; and

WHEREAS, the FDOE properly field tested the FCAT before issuing school grades in 1998; and

BE IT RESOLVED by the School Board of Duval County: That the Florida Legislature, in cooperation with the FDOE, fully implement the new standards and test all students and grade levels during the 2014-15 school year while transparently publishing all results at the district, school, and teacher level to establish baseline data and not tie 2014-15 results to teacher and principal evaluations and the retention of students at the third grade level. Whereas the FDOE properly field tested the FCAT before issuing school grades in 1998,
