Mr. Brent Wilder, PFM Group, shared with the Board that Duval is in much better shape than many Districts throughout the state. We are not as leveraged as most districts, and our debt is lower than most. Our current rating is AA, which is one of the highest in the state. There is nothing we can do right now with COP to reduce the deficit. He indicated that our District has done a nice job of taking advantage of what is available.

The Board discussed what options were available and the decision was made to pursue a QZAB. An item will be brought to the November Board meeting.
