RECOGNITION - ANGELA PHILLIPS PRESIDENTIAL AWARD FOR EXCELLENCE

Minutes:

Angela Phillips is a fifth grade math teacher at Chets Creek Elementary and is a recipient of the Presidential Award for Excellence in Mathematics and Science Teaching. A total of 213 educators nationwide received this distinction, which is awarded to exceptional K-12 math and science teachers. Mrs. Phillips has taught at Chets Creek for the last 16 years and has made numerous contributions to her school and the district. This includes facilitating professional development, consulting schools locally and nationally, and serving as a writer of the district's math assessments and instructional guides for supporting standards implementation.

Last week, Mrs. Phillips was in Washington, D.C. where she and the other recipients were recognized at a special ceremony. She was also presented with a \$10,000 award from the National Science Foundation. She is also joined by Chets Creek Principal Susan Phillips.

RECOGNITION - FLORIDA HEALTHY SCHOOL DISTRICT

Minutes:

Duval County Public Schools has received an honor achieved by only five other districts in the state. Ms. Vanessa Hodak, Vice-President of School Health & Wellness, Dairy Council of Florida, explained that there was a joint collaborative effort with other community groups that went into presenting this award. She also explained how the scoring was done.

RECOGNITION - AMERICAN HEART ASSOCIATION TOP STUDENTS AND SCHOOLS

Minutes:

We now recognize the efforts of two schools and two students who helped raise funds for extremely worthy causes.

The American Heart Association implemented "Jump Rope For Heart" and "Hoops For Heart" in many DCPS elementary and middle schools. Mark Owens, Youth Market Director for the American Heart Association, is here to present trophies to the top supporting elementary school, middle school, and the two top students within DCPS.

First, the Top Supporting Elementary School for the 2015-2016 school year is Alimacani Elementary. Alimacani raised \$9,651 for the fight against heart disease and stroke. Accepting the Jump Rope For Heart Trophy is Volunteer Coordinator and Alimacani PE Teacher Mr. Aaron Jones and Principal Kathy Stalls.

The Top Supporting Middle School for the 2015-2016 school year is Mandarin Middle. Through Hoops For Heart, Mandarin raised \$2,230.92. Volunteer Coordinator and Mandarin PE Teacher Amy Brown and Mandarin's Principal from last year, Dean Ledford, are here to accept the award.

Finally, we recognize the top two supporting students for Jump Rope For Heart. These inspiring young leaders raised over \$1,000 as they put it, "to help those with sick hearts."

For Conner Fox of Fishweir Elementary, his inspiration was a long list of close family and friends who have been affected by heart disease; a list his mother shared with the American Heart Association. Joining Conner is Fishweir PE Teacher and Volunteer Coordinator Michael Knight and Principal Kimberly Dennis.

Mayport Elementary's Xavier Willis is an overcomer affected by three heart conditions. He participated in Jump Rope for Heart not only as

a survivor, but also in remembrance of his father, who passed away at a young age due to Juvenile Diabetes. Thanks to the American Heart Association and advancements in research and technology, Xavier's conditions are monitored on a regular basis and has not had to go through surgery. Joining Xavier is Mayport Elementary and Volunteer Coordinator Sara Baker and Principal Amy Cline.

The American Heart Association would also like to thank the Duval County School Board, Dr. Vitti and his staff, the Wellness Department, Principals, faculty and staff, students and families for their partnership.

Chairperson's Report

CHAIRPERSON'S REPORT

Minutes:

Ashley Smith Juarez, Chairman Duval County School Board This weekend we observed the anniversary of the 9/11 attacks. As I reflected on the events and the years since that tragedy, I was and am filled with gratitude for our first responders and members of our armed services. I am so grateful to our school police, JSO, JFRD and all first responders and service men and women for your service. You choose to serve and protect each day. Thank you.

In the last month the Board has continued to move through our process for adopting the 2016-2017 annual budget. Tonight, we have on our agenda an item to finalize the 2015-2016 annual financial report. This item appears as an emergency item not because there is any alarm but only because, as Chairman, I chose to shift the item to tonight's agenda rather than hold a special meeting last week. This was done for efficiency of time and no other reason.

Last week, the Board gave the Superintendent his evaluation for the 2015-2016 school year. Because time did not allow for the formal Board statement to be completed in advance of this meeting, that will be presented at a future time. That being said, I did want to highlight one area that the Board recognized as a commendation at our evaluation meeting.

We have enjoyed a strong relationship with Florida State College at Jacksonville (FSCJ) to deliver Dual Enrollment and Early College programming for years preceding my tenure on the Board. I'd like to read you a recent email from the Superintendent to the Board that outlines the success of Early College students and instructors:

I am pleased to let you know that 87% of students participating in the Early College Program successfully earned their Associate of Arts Degree (A.A.) in 2016. This far exceeds our completion rate of 70% only two years ago. 143 students who entered college two years ago met all requirements needed to earn their Associate of Arts Degree. The Early College Program at Jean Ribault High School had the highest percentage of students earning degrees with 94% of the original cohort completing their degrees within the four-year time frame. We have made strong improvement in this area.

Below you will find a further analysis of this data over the last three years.

When I received this good news I sent it along to an FSCJ trustee, Tom Bryan, with whom I have worked to champion the opportunity of Dual Enrollment and Early College and I want to also read his insightful response.

Thank you for this amazing news! So if we use a \$20,000 figure on college tuition, room, board, meals, etc per year for each of these students and we know utilizing this program, they saved two years of college costs for them and/or their parents, then 143 students x \$20,000 x 2 years = \$5,720,000.00 value for attending a local public high school offering dual enrollment/early college!

Add to that if, say half of them, obtain a masters degree in four years and start working two years before their contemporaries, they earn an average of 25,000 dollars per year. Over a 30-year working career that adds a minimum \$750,000.00 in income to each of those 71.50 students x 30 years =\$53,625,500.00. cumulative value... not counting any interest. So this program can be said to have generated a value of over \$56,000,000.00 this past YEAR. Not a bad return in my opinion. That's the kind of payback that should make a few people take notice.

This is truly a remarkable partnership with remarkable results.

Tomorrow, the Board will meet in its monthly workshop to revisit setting future targets and charting a path for expanded success for all of our students.
