The Chairman of the Grievance Committee explained the ground rules:

- The Grievant will present its case first
- Staff will present their case
- Both sides will have an opportunity for rebuttal on points previously made
- The Committee will then ask questions
- The Committee will deliberate, make a recommendation, and take a vote

Mr. Archibald Thomas, Attorney at Law, presented on behalf of the Grievant, Ms. Diane Brinson. Ms. Brinson alleges that her non-reappointment to the position of Assistant Principal was not related to her performance, but rather to the Principal Gail Brinson's beliefs and state of mind. The Grievant understands that when you are on an annual contract there is no duty to renew, however, she was told that she was not reappointed due to performance and she is alleging that the proper assessment procedure was not followed when her performance was evaluated.

Ms. Vicki Reynolds, Chief Human Resource Office presented on behalf of the administration. Ms. Reynolds indicated that the problems the Grievant was having did not just arise and that her evaluations from the past 2-3 years reflected various concerns with the performance. She was afforded meetings with her Cluster Chief regarding the evaluation from this year. The Grievant was offered a position as a classroom teacher and is currently performing that job.
