#### Minutes:

Board Member Hall mentioned that Michelle Begley, Internal Board Auditor, sent an email to the Board earlier in the day alerting them that there was a shortage in the budget. Board Member Hall asked if the shortage problem had been addressed. Dr. Vitti didn't feel there was a budget shortfall. He considers shifting money around among accounts to be typical budget management practice which is what has been done in the past. Ms. Begley's concern was that Cabinet add-on funds and Maintenance salaries together showed a shortage of approximately \$28 million. Those shortages are usually resolved by the time of the final budget meeting, but that is not the case this year. She would like to know how administrators intend to make up that shortage. After much discussion, Chairman Smith Juarez recessed the meeting until Monday, September 19, 2016 to give administration time to earmark funds for the shortage.

The meeting was recessed at 6:36 p.m.

The meeting was later reconvened on September 19, 2016 at 5:03 p.m.

Dr. Vitti explained that there are two areas in the budget that could temporarily be used if, at any time, there were not funds available to move over into salaries. One area would be money in reserve which is

currently at 5%. If that were needed, the amount would never be drawn down below 3%. It would be a temporary use and funds would later be replaced. The other funding source would be \$10 million that was set aside for teacher pay increases over a 3-year period. Many teachers are now drawing their third year of a pay increase but the \$10 million has not been needed. Dr. Vitti expects the add-on list to be "cleaned" and funds in place for the rest of the year by the end of October.
