# 3. RECOGNITION OF INTERNS

Minutes: IT Interns Recognition

• The next presentation recognizes a group of students whose enthusiasm and interest in the computer science services delivered to schools and departments helped make a huge impact on the district's technology.

• During the summer, DCPS' Technology Department introduced seven deserving students to the world of information technology.

• These students were given the opportunity to participate in a seven-week internship program where they assisted IT professionals with a major district technology project – the upgrade of thousands of computers for teachers and district employees.

• In order to be considered for the internship, eligible students were required to:

1. secure a recommendation from either their principal, a School Technology Contact, or Chief Officer,

2. be at least 18 years old,

3. be a current student or recent graduate, and

4. have moderate to expert computer skills.

• Upon meeting the minimum requirements, each candidate completed Duval County Public Schools' hiring process, which included participating in interviews and employee training with Human Resources.

• With the help of these seven students, the district was able to upgrade nearly 1,200 Lenovo desktops and laptops, and update more than 1,700 ILits and iPads.

• As a result of their hard work and professionalism, three of the interns were offered full-time positions with district business partner Emtec, a company that specializes in helping organizations leverage technology to achieve their business objectives.

VPK Program Recognition

• The next presentation highlights the efforts of Duval County Public Schools' VPK program and its successes in providing superior early learning opportunities for students.

• The Guiding Stars of Duval is the Quality Rating Improvement System, known as QRIS, for child care centers that assesses, improves, and communicates the level of quality in early care and education programs in Jacksonville and Duval County.

• QRIS helps develop a roadmap for aligning many pieces of the early care and education system, including child care licensing and pre- k program oversight, accreditation, early learning guidelines, subsidy administration, and technical assistance and training.

• After working with the Jacksonville Children's Commission and Early Learning Coalition for two years, the Possibilities and Success Childcare Center completed the Guiding Stars evaluation and earned a rating of four out of five stars.

# Comments From Audience

COMMENTS FROM AUDIENCE

Minutes:

Chairman Couch welcomed Congresswoman Corrine Brown.

Congresswoman Brown expressed two concerns to the Board that has been brought to her attention by her constituents. One is the discontinuation of summer programs at both Bethel Baptist Church and St. Paul AME Church. Both those programs enable students who failed a course during the school year to attend the summer program and pass the course to get back on track academically. It was a joint effort among the churches, Florida State College of Jacksonville and other community stakeholders, so she is wondering why the program has disappeared or was it replaced by a different program?

Congresswoman Brown's other concern is with new requirements for standardized testing which is now to be done on computers. Many underprivileged students don't have computers in their homes which will put them at an extreme disadvantage. How is this issue being addressed?

One other concern Congresswoman Brown had was on open enrollment. She has

received comments from families and the community. She wants to make sure we have that kind of dialogue with the community moving forward.

Linda Wiggins Scholar Preparatory Academy

The school received a 90-day Termination Notice from the district. They are working with them to eliminate problems. At this point in time there is only one, which is the minimum enrollment. They are working very hard to clear up the problem and hope the district does not issue the 90-day Termination.

Reginald Caldwell, Associate Pastor Bethel Baptist Institutional Church

Bethel Baptist Institutional Church has had the B.E.S.T Academy for a number of years to help struggling students during the summer. Please support and put the program back together.

Pam Mullarkey Project S.O.S.

Dr. Vitti brought the Project S.O.S. program into the Title I middle and high schools for one semester. The program went so well that it is now extended for the entire school year.

Melita Jara, Parent

Her two sons are recipients of scholarships which have made a drastic difference in their education. Extensive testing caused them to have a lot of homework which caused a high level of stress. The scholarships have allowed them to attend a school that is more individualized for them and they are now doing so well they have skipped a grade. They are happy to be in school now. She wants to thank whoever is involved in making those scholarships available. The program is very valuable and it upsets her to think it could go by the wayside.

Bradford Hall

Congratulations to Board Member Paula Wright on her re-election. Is there anyone at tonight's meeting that can inform the public about whether the QEA Fund Advisory Board will conduct it's meeting in the Sunshine?

Annalee C. McPhilomy, Retired Teacher

When she first started teaching, kids enjoyed coming to school and being active and involved instead of working to make money. Over the years, things have changed and a lot of that is due to testing. Activities that allow our students to interact are VERY important; simply working hard at school is not enough. The hard work with little to no activities for students to enjoy is the wrong direction for our schools. The balance between hard work and activities needs to be brought back to the school system.

Leanne King Florida Parents R.I.S.E.

When Senate Bill 864 was passed this year, she considered it a blessing. It enabled the local communities to take control of their curriculum materials. If the School Board evaluates the materials being used in curriculum and runs across barriers, parents want the Board to bring those barriers to the parents; they can overcome them. Are there any ELA or math books that are not Common Core aligned? Please bring the decision of the curriculum back to the community.

Frank L. Humphrey III

He is here to give a thank you. He attends Manhatten School of Music in New York City. He is here to testify that the Duval County School System works. He attended Duval schools throughout his education K-12. He still keeps in touch with many of his teachers. Parents need to help students to understand the importance of showing respect to their teachers; they will later need to ask the teachers for recommendations after they are out of school.

Shannon Kubisiak, PTA President Holiday Hill Elementary School

There is a new program at Holiday Hill Elementary that has kids walking before school. The teachers love the program. The kids are getting their "wiggles" worked out before they show up for class and are more focused. The benefits are so impressive we would love to see this program throughout the whole district.

Sharitta Holder, Parent Scholar Preparatory Academy

She has only lived here for one month and she looked for a school here in Duval County that offers a specific curriculum which she found at Scholar Preparatory Academy. It is the only school that offers it. Her kindergarten student moved on and did first grade work during the school year and she doesn't even know if that's possible in other schools. The 90-day Termination Notice has her concerned that it would discontinue the curriculum she favors for her student. She feels if more parents knew about the curriculum offered at this school, more parents would enroll their children there.

# Nancy McGowan

She has been researching Common Core for the past 10 months and believes the monopoly with Pearson Publishing will end with a mandated iPad policy. The curriculum is inferior and are not standards. When iPads are incorporated, the Board needs to keep in mind that doctors and pediatricians say there is a 2-hour max screen time. The Fins are beating us with textbooks, paper and pencils. The forced monopoly in all this is what has her concerned.

#### Step Up for Students

Are vouchers constitutional? 2002 Supreme Court decided they are. The voucher program allows low-income households to choose the school their students attend. The program has allowed him to send his students to a school with no bullying issues. They have bought uniforms for their students. What are they to do with them now if the school is not allowed to stay open?

Jennifer Tomlinson Step Up for Students

The scholarship program has allowed her to put her two children into a private school which has helped her older son, who attended public school, to do better. While in public school, he dealt with bullying and was not comfortable. Once he made the change to the private school, his whole demeanor changed, he is more active and thriving in his education. She has two children, she's single and afraid of the type of education they would be getting if she were to lose the scholarship. Please stop the lawsuit; it's uncalled for. She's appreciative to whoever started the program.

## Tiffany Clark The Potter's House Christian Academy

She and her husband have three children in private school. Their oldest is serving proudly in the military and his friends have been accepted into many well-known universities. She and her husband are products of the public school system. She is not here to bash public school but feels that they, as parents, have the right to choose the best school environment for their children based on their situation.

## Kelly Lorbeer

She is a product of Duval County Public Schools. She comes tonight concerned about testing. It teaches students what to think but not how to think. The excessive testing lines the pocket of the testing companies. There is no evident the testing will lead to more knowledgeable or career/college-ready students. President Obama and Arne Dunkin, Secretary of Education and Bill Gates, Financier of high stakes testing, do not send their children to school that conduct high-stakes testing. On August 22, 2014 Dunkin stated that we need to give teachers a reprieve from being graded on the student for the next year because testing is sucking the oxygen out of the classroom across our country. One year from now the oxygen masks won't fall from the sky for the students. Our board members are the life support for the students today. Dunkin did not give the students an oxygen mask. Instead, he supported the teachers. Please give our students a reprieve.

Debbie Higginbotham Florida Parents R.I.S.E.

Lee County wants to opt all their students out of the high-stakes testing being conducted by American Institute for Research (A.I.R). State has admitted tests are experimental but the results will stay with our kids for their entire academic career. We're not opposed to having standards and tests. These tests are embedded with a

30% failure rate. They are designed to fail 30% of our students. It's not fair; they are setting our students up for failure. We want them set up for success.

#### Lisa Williams, Parent

She is very upset over the treatment of her son Carlton Williams who was a student at First Coast High School by both the principal at Raines High School and Dr. Vitti. She insists she and her husband have taken accountability for their son's actions, who was defending himself from an attacker, as well as their other children who are productive citizens in society and another who is a senior at Ribault High School. Her questions to the Board: Where is the accountability for 52 D and F schools in Duval County? Where is the accountability for all the fights and lack of security on our school campuses from north to south and east to west? Where is the accountability for providing false and inaccurate information about my son to the media, thus defaming a student? Where is the accountability for entering discipline referrals into the districts computer system using a date my son wasn't even in school? Where is the paper copy of the referral? The administration has not been truthful about the event. If the Board has to resort to blaming parents and students for poor choices of administrators, it questions their ability to lead and sums up why there are 52 D and F schools in Duval County.

#### Carlton Williams, Parent

He and his wife requested a meeting with the full Board. Was contacted by Ms. Wright to bring paperwork regarding the Raines High School incident to her at Northwestern Middle School. Upon arriving, he realized the meeting was with Regional Superintendent Iranetta Wright, not School Board Member Paula Wright. We don't want to be contacted at this point by anyone other than a board member informing us of when we can have our meeting with them. We realize it must be a public meeting which is fine with us. The Superintendent falsely attacked our son in public and we have no problem holding a meeting with them in public.

## Laurie Coverdale, Parent

Her students are now in private school because of the scholarship program. Her students enjoy smaller classroom settings and feel they have a better educational opportunity there. This is not an intent to bash the public school system. It does work for other students. Please consider keeping the scholarship program.

#### Derek Bermudez

He has an opportunity to coach at a public school. One thing holding him back is his record of a felony. He saw on the news that Dr. Vitti was pushing to hire convicted felons to talk to kids. He has gotten his voting rights re-established and has attended board meetings and city council meetings to get acquainted with agendas. Football afforded him the chance to go to college and get a degree from Edward Waters. I'd like to work with someone to get past the red tape so he can work with reaching young men. The issues he had were during teenage years. He's 36 now.

## Marvin Lockett

He filed a complaint with Department of Education after being surplussed from A. Philip Randolph. It was supposedly due to incompetency but he knew it wasn't due to that. He assumed somewhere along the way he crossed a line or made some enemies somewhere. He was still terminated after 3 years. There is now a red flag on his record. Please consider him for a rehire. His calling is to lead. Either in the school system to turn around failing schools or possibly later as a pastor.

Gisele Clair Savoury

She retired from active duty with the National Guard so she could be home to take care of her son. She is taking this opportunity to return to school and relies heavily on the scholarship program for her son. The choices it gives her allows her to put her son in a school with uniforms which she values highly. Her friend's daughter went to public school where she was failing. She was a far cry from being stupid. She convinced her friend to put her daughter in a private school where she is now thriving. That convinced her to put her own son in a private Christian school.

There was no second. Board Member Fischer said, "I think that's at your discretion." Chief of Legal Services Karen Chastain clarified that the Chairman can rule whether an item is deemed to be an emergency item to be placed on the agenda without a motion or second. Chairman Couch said the lawsuit is brand new and the Board will have time to review and discuss the matter at the next workshop.

Board Member Fischer moved, "we suspend the rules to allow the Resolution to be placed on the agenda. I think we heard several speakers come in tonight. For the affected low income families, this is a real and immediate issue. It's an emergency item to them and this item would have been brought forward earlier by me had the lawsuit been filed prior to the agenda being published. I would have put it in then. The other reason that it's also, I think, an emergency is because we have two members of the board of directors on FSBA and the FSBA board of directors' meeting is coming up on Friday and I think it would send a clear message that we think they should withdraw from this lawsuit because it hurts low income children all across the state, particularly in our city. There is about 5,000 families because their lives have been put into chaos and confusion over this issue. We could resolve that by supporting this. There was no second.

Chairman Couch explained the Board policy is linked to the state statute that outlines the ability of parents to opt their students out of the reproductive health curriculum. State statutes says a parent has to be given the notice that they are going to cover reproductive health and they can go and view the curriculum and then they have the opportunity to opt their student out.

Mr. Sam Hall asked for information on Board policy 4.15, English for Speakers of Other Languages. Chairman Couch re-read the policy and explained that the only change was a typo correction.

After the motion and second, Board Member Fischer indicated the state statute is written so district values can be reflected in board policy. #### Board Member Jason Fischer

What a wonderful day it is to be in our city here in Duval County. Our school year started and we are wasting no time in the education of our youngsters. The Superintendent and I visited a few schools in the first week, the kids were already at it solving math problems, reading novels, learning about the 13 original colonies. From what I could tell, our children were excited to be back at it; so I'm excited along with them for the start of the school year. We voted on a lot of good things this evening; a lot of great things. I have confidence that they will help our district improve. I wanted to discuss two items before I close out the evening. The first agenda item that we spent a lot of time on; I didn't think we were going to and that was the Bake Sale Exemption. The federal government, in it's great never-ending wisdom decided it is a priority to tell Duval County parents what they could or couldn't do at a bake sale. There are many other issues that our country needs to address but somehow through the Department of Agriculture this was a priority for the federal government. As an example, we spent more time discussing this bake sale exemption than the federal government has spent time trying to bring home the highly decorated marine Sargent Andrew Tahmooressi who's languishing in a Mexican prison through no fault of his own. How about we bring him home and let the parents of Duval County decide the contents of a local bake sale. I'm proud we rejected that and gave those parents an exemption, even if it's only for a short time.

The last item I want to bring up is something that was subject to public comment in a Resolution I tried to introduce earlier this evening. Had this lawsuit been filed prior to our agenda being published I would have submitted this Resolution much earlier. This Resolution is important not only because of the timing of the lawsuit but also because the Florida School Board Association's quarterly board meeting is on September 5th and that's why I pushed to make a decision tonight so it would be relevant for that meeting. For the affected low income families, the people you saw come to speak tonight, the families that are impacted by this lawsuit, the issue is real and immediate. It's an emergency to them. We are dues-paying members of FSBA and as you know, if their lawsuit is successful, it would deny low income children, some of the poorest children in our community, the right to attend a school of their choice. This issue has unnecessarily created concern and chaos in the lives of tens of thousands of disadvantaged families across the state of Florida, almost 5,000 of those families in Duval County alone. It's appalling, it's shameful in my opinion. Why in the world would anybody attack students who are the most vulnerable and the most struggling. It's not because of the financial impact. Over the years, one independent study after another has examined whether tax credit scholarships are draining money from public schools and each one of them has concluded that it's not. The most recent analysis by the State's Consensus Revenue Estimating Conference projected that scholarships would save the state 58 million dollars. We know the opposition isn't because of academic results either. Scholarship students are required by law to take standardized tests and for seven years now, the results have been required by law to be analyzed by David Figlio, top notch researcher at Northwestern University. Scholarship students

were on average the lowest performers in the public schools they attended. But now, in their new schools, they are making the same learning gains as students of all income levels nationally. So what's the problem? Sadly, it involves turf and power. If we truly wanted what is best for our kids, we wouldn't care what kind of school they succeed in; only that they succeeded. It's past time to put aside all the fights we're having over school types, whether district or charter, private or virtual and focus on bigger problems that continue to fester. The truth is, when it comes to fighting poverty and illiteracy, public schools need all the help they can get. Tax credit scholarships aren't the end all, be all, but they are part of the solution. In lieu of reading the Resolution that we'll be discussing next month, I'll submit it for the record.

#### Board Member Paula Wright

On the first day of school, Ms. Wright visited First Coast High School, Highlands Middle School and Andrew Robinson Elementary School with Mayor Alvin Brown. We have a lot of issues before us but she doesn't know of any low-income family that makes \$62,000/year which is the threshold of this voucher system. Florida School Board Association (FSBA) is challenging the voucher system, asking if it is constitutional and does it provide the accountability we need for our tax dollars. The Duval County School Board is not a part of the lawsuit brought forth by FSBA. In the aftermath of her reelection, she looks forward to serving Duval County Public Schools and more specifically, District 4.

#### Vice Chairman Grymes

On the first day of school, she and Dr. Vitti visited Lake Lucina and Arlington elementary schools as well as Terry Parker High School. Many thanks to Fidelity Investments for partnering with Terry Parker on beautification efforts. Also, many thanks to Sonita Young and her staff for working hard to have our teachers in place on day one of the school year.

## Board Member Ashley Smith Juarez

We had a smooth and great start to our new year. Thank you to both first year and experienced teachers as well as parents and principals for the effort involved in getting kids back to school. September is Childhood Cancer Awareness Month. Please be mindful of the children who are battling those challenges.

## Board Member Connie Hall

Congratulations to Rutledge Pearson Elementary School for being named one of six schools in Florida as the highest performing and cost effective analyzed by the Florida Tax Watch. Raines High School has a series of events planned to promote a health mind, body and soul.

## Board Member Fred Fel Lee

Echoed his thank you to Human Resources for filling vacancies. Congratulations to Seabreaze Elementary and San Pablo Elementary for their PTA's and SAC's. Principals

and lay leadership make a huge difference in schools. Also, thanks to the Superintendent and his staff for keeping an eye on class size.

Chairman Becki Couch

Reminded everyone that the Board workshops and Committee meeting are available on the website. She is also very much aware of Childhood Cancer Awareness month having two of her friends with a child in each family under the age of eight battling cancer. She recommended Board Member Fischer can have her read his Resolution to the FSBA Board when she goes to the meeting this week. She also recognizes the concern for Step Up For Students program. She sees it as a school choice that certainly is not going away but would like to recognize that but do it in a way that is equitable and with accountability. Whatever that decision is we arrive at, it needs to be applied equitably across all schools, regardless of the type of school it is. When we don't apply it equally, we send a mixed and confusing message to our citizens, especially if it's at the expense of the taxpayers. She encourages everyone to research the issue, then make their opinions known, not only to local elected officials, but state and federal as well.
