#### Minutes:

The Chairman opened the discussion, providing background on the evaluation process, and indicating that each member had met individually with the Superintendent to discuss their evaluation and this meeting was to collectively share their comments and

turn in their evaluations. Staff will then combine the scores and share a matrix with the Board prior to release to the public. Copies of related documents are attached to the Minutes.

#### Comments included:

- Board Member Hazouri overall acceptable performance; concern with certain personnel decisions; Superintendent will be held responsible for decisions
- Board Member Wright concern with staff and organizational relationships; lack
  of targeted activities and programs that would move our students beyond
  intervene status; overall between acceptable and needs improvement
- Board Vice-Chairman Burney main areas of concern include staffing and educational leadership; overall was between acceptable and needs improvement; positive aspects include his relationship with the business community and the community at large
- Board Member Couch would like to see evaluation instrument revised to align more the that of the Principals and teachers and tied to data; Superintendent clearly cares about children and works well with the community; shares concerns of other Board members regarding staffing and organizational relationships; overall acceptable performance
- Board Member Barrett agreed we should update evaluation instrument;
   Superintendent speaks well and has a good relationship with the community;
   takes criticism well; treats Board members the same; same concerns with staffing; overall highly effective
- Board Member Lee has good relationship with the Board and with the community; shares concerns with staffing and organizational effectiveness; good fiscal leadership; area of concern is bringing policy consensus before discussing changes; overall needs improvement
- Chairman Gentry agreed that the evaluation instrument should be revised and asked that Board Members Lee, Burney, and Couch work on this as a Committee. He asked Board Member Couch to Chair the Committee. Feels Superintendent should be more assertive; has great relationship with the community and business partners; shares concerns expressed by other members regarding staffing and organizational effectiveness; overall highly effective

The Superintendent made the following comments:

#### Section 1

- Will discuss our Strategic Plan at the September 15, 2011, Board Workshop and will be making recommendations at that time.
- Board has taken positive stands on requiring students to complete a postsecondary curriculum; acceleration programs is another area which is positive; along with expansion of the Career Academies.
